erybody ought to have lilacs."

During the lunch with Commissioner Paris and Larry Garrett, Gray exposed them to written materials harvested from the festival in Rochester.

"Lamar and Larry were sitting there and I started telling them about this and Lamar said 'how much do you think that is going to cost?' I told him around \$2,000 to \$2,500 would suffice," Gray said. "He said 'okay.

"I was shocked, but that's the kind of commissioner that we have, he can make a decision and see the future," Gray said.

In 2007, an 18-wheeler arrived from Canada with more than 200 lilac plants in tow.

In 2007 and 2008 those precious plants were put in the ground at Meeks Park, behind the Senior Center and at the Golf Course.

'It's been sweet memories of lilacs blooming ever since," she said. "This collage of wildflower photos is presented to the Commissioner Paris for his insight and willingness to order those lilac bushes for the Park, the Senior Center and the Golf Course in 2007."

The lilacs consist of 30 varieties and seven colors, and the plants ranged in three categories: early, mid, and late-blooming, Gray said.

"This collage is a testament to Commissioner Paris," she said. "Next time you are in the area of Meeks Park or the Senior Center, let your nose lead you to the fragrant blossoms, even before your eyes spy them," Gray said. "Look for the lilacs on both sides of the road to the main parking lots at Meeks Park, and in the park opposite the Nursing Home.3

Commissioner Paris said the lilacs are a beautiful reminder of spring in Union County.

"I want to thank Arlene for

bringing lilacs to my attention," he said. "They certainly are beautiful." In other business, Com-

missioner Paris: Proclaimed April as Donate Life Month in Union County. 'One of the most meaningful gifts that a human being can bestow upon another is the gift of life," Commissioner Paris said. "More than 11,000 Union County residents have already registered their decision to give the gift of life.

Proclaimed April as Confederate History and Heritage Month.

"Our country is a nation of people united by a common history of individual heritage and diverse cultures and Union County is rich in history of the War Between the States," Commissioner Paris said.

"This month, bears special significance since it marks both the beginning and the ending of the War Between the States," he said. "I encourage all residents to increase their knowledge of the role played by the Confederate States of America in our country's history.'

Proclaimed April 19th, as Patriot's Day in Union County.

"On April 19, 1775, Paul Revere, William Dawes and Dr. Samuel Prescott raced through the Massachusetts countryside to warn fellow citizens that British Troops were coming to arrest their leaders and seize their storage of munitions," Commissioner Paris said. "This marked the beginning of the war for American Independence. I encourage all residents to honor the many Patriots for whom Georgia counties are named and pay tribute to all the Patriots of the American Revolution.'

Approved the Memorandum of Agreement between Union

County and Avita Community Partners to provide the facility and utilities for the center at 76 Hunt Martin Street, Suite A. Avita provides mental health, developmental disability and addictive disease services to residents of Union County.

Issued a business license for cabin rental, to NatureLovers Getaway, Upper Plott Town Road, Blairsville. This is the only business the county issues for and it is for hotel/motel tax purposes.

Accepted the Cooperative Enforcement annual operating plan and financial plan between the Union County Sheriff's Office and the USDA, Forest Service, Chattahoochee-Oconee National Forests. The Fiscal 2012 total annual operating plan is \$3,000.

Accepted a letter of agreement for professional design services for the Union County Senior Center addition from R Design Works. The lump sum fee is \$15,000, or, 5 percent of the anticipated \$300,000 total budget. This contract is contingent upon Union County receiving funding for Senior Center expansion.

Appointed Kris Gooch to the North Regional Planning Board for Mental Health, Developmental disabilities, and addictive disease as the representative of Union County. The appointment is for three years.

Accepted the agreement between Union County and Data Survival Inc. The total recurring monthly cost is \$54.

Accepted the agreement between Union County and Hayes James and Associates for groundwater monitoring at the closed landfill. The total cost for the monitoring is \$87,968. It includes spring semi-annual assessment monitoring, fall semi-annual

compliance monitoring based on actual time and expenses. This work will be invoiced monthly based on actual time and expenses in accordance with hourly rates. This work is being done at virtually the same rate in accordance with the hourly rates. This work is to be done at virtually the same rate as in the past few years. The county has changed to a local company in hopes of having control of the process.

Approved the drug/alcohol testing policy for the Union County transit system.

Reached an agreement for the 2010 Homeland Security Grant Program. This is an FY10 Bomb Dog grant for the sheriff's department for the Union County Sheriff's Office in the amount of \$43,500.

Welcomed new North Georgia News Editor Charles Duncan. "Charles has a lot of good newspaper experience, is from Union County and we look forward to working with him," Commissioner Paris said.

Wished former North Georgia News Editor Norman Cooper well and thanked him "for the outstanding job he has done for not only his coverage of Union County Government, but his very positive coverage of our community and county, Commissioner Paris said. "Norman has worked for the North Georgia News for 17 years and while there were times that we might not have always agreed with him, you can never doubt nor ignore his work ethic and complete dedication to Union County and the North Georgia News.

"While Norman says he will still remain active in our community, he will be missed, and we can only wish him the very best moving forward.³
