Inspections, Testing and Maintenance

Earlier this month, FBI Director Wray testified before the House Judiciary Committee. Yet despite the hours-long hearing, Wray ducked and dodged his way out of answering critical questions related to numerous scandals surrounding the weaponized agency.

More than two years have passed since January 6th, 2021, yet Wray provided little to no insight on the matter. For example,

Wray failed to provide transparency amidst ongoing concerns regarding the FBI's involvement in the Capitol riot on January 6th. After telling a Committee Democrat that it was "ludicrous" to suggest that FBI agents orchestrated an operation on J6, Wray later refused to answer straightforward questions about



whether the FBI had confidential human sources present that day Even when pressed by a Republican on information related to the two pipe bombs left at both the RNC and DNC, Wray stonewalled — hiding behind the active status of the investigation.

But Wray's efforts to evade basic questions extended beyond the topic of January 6th.

Numerous Committee Republicans grilled Wray on the agency's brazen double standard in the treatment of President Trump and President Biden, with additional questions zeroing in on Joe Biden's corrupt behavior. Due to his lack of interest and answers, Wray was

directly asked if he protects the Bidens. Wray, of course, replied: "Absolutely not. The FBI has no interest in protecting anyone politically."

Give me a break. While Wray will never publicly admit to the FBI's increasingly politicized and weaponized actions, the American people know good and well that this ongoing behavior is rotting the agency from the inside out.

And these nefarious efforts aren't just aimed at high-profile Republicans. Everyday Americans continue to bear the brunt of the FBI's dishonorable and unlawful behavior. From targeting concerned parents at school board meetings to punishing pro-life activists and surveilling religious Americans, the FBI has undoubtedly overstepped its bounds. Despite legitimate concerns about these widely reported activities, Wray largely sidestepped related questions during the House Judiciary Committee hearing.

Ultimately, the vast majority of questions directed at FBI Di-

Commissioner's Questions

This week's questions and answers focus on the Union County Senior Center. Kathy Hill is the Director and in charge of participation and activities at the Senior Center. These questions are some of the most common questions we receive, and the answers contain general information. If you have further questions you can call the Union County Senior Center at 706-439-6105.

Q. Where is the Senior Center located?

A. The Union County Senior Center is located at 95 Senior Center Drive. If you are traveling west on Highway 515, you turn right on Meeks Avenue as if you were going to North Georgia Technical College.



The first road immediately to your left is Senior Center Drive, and the Senior Center is at the bottom of the hill on the left. The Senior Center is available for Seniors who are 60 years old or older.

Q. Who do I contact about getting an elderly family member signed up for Meals on Wheels?

A. You can call the Senior Center at 706-439-6105 to get your family member signed up for the program or for additional information. The Meals on Wheels program provides home delivered meals to qualified seniors. There is no cost for this program, however everyone is allowed an opportunity to donate toward their meals if they are able to do so.

Q. What type of programs does the Senior Center offer?

A. The Senior Center is open Monday through Friday from 8:00 am until 4:00 pm. They offer a wide variety of programs throughout the day which includes various exercise programs, quilting, acrylic painting, crafts, Bingo, Wii Bowling, and even line dancing. Each day at 11:30 there is a congregate meal provided at the Senior Center also. This is a great way for seniors to get a hot meal and socialize at the same time.

Q. Are there any activities for senior citizens who have Alzheimer's?

A. On Wednesdays and Fridays from 12:30 to 3:30 the Alzheimer's Respite Program is available. To participate in this program the individual must be approved prior to participation. Is It Ripe?

One question that people will call me with is how to tell if a fruit or vegetable is ripe or not. Different plants ripen differently. Some will continue to ripen after they've been picked, others need to ripen attached to the plant. Let's talk about what causes plants to ripen and how to tell if some common fruits and UGA vegetables are ripe or not. Watching Fruits and and Working vegetables are divided into cli-Jacob macteric and non-Williams climacteric. The difference between these groups is their response to the hormone ethylene. Ethylene is a hormone that plants produce to induce ripening. Climacteric fruits and veggies will continue to ripen after they have been picked. Non-climacteric fruits and veggies won't continue to ripen. Instead, they will soften and rot as they age. Some crops are sensitive to ethylene and so shouldn't be stored with climacteric crops that produce ethylene. Apples, pears, peaches, plums, potatoes, and tomatoes are some examples of climacteric plants. Blueberries, blackberries, raspberries, cherries, cucumbers, eggplant, grapes, strawberries, peppers, squash, and watermelon are all examples of non-climacteric crops. Some examples of plants that are sensitive to ethylene and so shouldn't be stored with climacteric crops are asparagus, broccoli, cucumbers, green beans, kale, onions, peas, peppers, squash, and watermelon. Now that we know a little more about the ripening process let's talk about how to tell when the best time to pick some of the most commonly grown crops around here are. Tomatoes are an easy one to tell when they are ripe because they start to turn red. You can pick tomatoes before they are fully ripe on the vine. Because they are climacteric, they will continue to ripen. I've put tomatoes up in the kitchen windowsill so that they'll ripen. Sometimes it is advantageous to pick something before it's fully ripe so that you make sure critters don't get it before you. Apples and pears can be a little more challenging to tell when they are ripe. Different varieties will ripen at different times. In addition, the entire tree may not ripen at the same time. If the apple or pear stem breaks away easily from the tree then it's ripe. Turn the fruit sideways to see if it pops off. Depending on the variety, you can use color to tell if the fruit is ripe. If you cut an apple open and the seeds are dark brown, it's ripe. Blueberries will be plump with a deep blue color. They also have a white powder on the skin that keeps them fresh longer. Squash and zucchini should be harvested when they're 4-8 inches long. They'll both grow See Williams, page 5A

Rock Bridge

The Rock Bridge had always intrigued me. Mom had told me stories of the place since I was old enough to remember. It was a place of natural beauty and it also had a reputation with a dark past. I visit the place in my dreams often, and every now and then I go back to visit. Even today it is beautiful Around and yet mysterious at the same time. The Farm Bill and Delphia Adams owned a small piece of Mickey land at the top of a Cummings ridge just above and west of Little Bear Creek. Just to the east of the creek and halfway up the next ridge, the Rock Bridge was located along with a saddle-shaped rock called Saddle Rock. Hiram Baker had settled this area in the 1850s, and after his death the land had passed from one Baker to another for three generations until mine. But, even before my ancestors came to the area, the Rock Bridge had a dark past. I have always been told that a family of Cherokee Indians lived under this bridge and their ancestors had lived there for generations before Christopher Columbus. Then two things happened which would change the way these people lived. First, Andrew Jackson was elected as President of the young United States. And second, gold was discovered in Dahlonega, Georgia. This was the excuse President Jackson was looking for which led him to sign an executive order leading to the removal of the Cherokee and Creek nations from their homelands in Alabama and Georgia. The soldiers came to the area around the Rock Bridge and rounded up the families and forced them on to the infamous "Trail of Tears." When the soldiers came to the "Rock Bridge," a young Cherokee woman screamed as she ran. In her attempt to evade the soldiers she slipped and fell from the top of the bridge, resulting in her death. It has been told many times that if you visited the area at midnight you could still hear the screams of the young woman as if she were running from the soldiers. Fifteen years after the removal, my 3X great-grandfather settled in the area. He and his wife, Mandy, built a log home not too far from the Rock Bridge. Mandy loved the area and spent many a day with her children exploring the area. She and her children swam in the creek and found a large rock from which they could jump into the creek. They built fires under the bridge to cook their lunch and even found a rock close by where they could sit and watch the creek below. It is said that Mandy haunts the Rock Bridge to this day. If you visit the bridge at midnight you can see her sitting there in a rocking chair rocking and singing her favorite songs. See Cummings, page 5A



As I was standing at the bottom of this tree scanning the top of the tree and vine for any ripe muscadines I heard something that made the hair on my neck stand up. Judging the location of the sound I figured it was coming from up close to the Rock Bridge. I was sure the sound came from a woman. It sounded like something you would hear on a scary movie. I could just imagine the scene of a Cherokee woman running along the edge of the Rock Bridge and falling to her death. The screams would begin and then stop for a time and begin again.

It didn't take me long before I decided to go back home. I didn't run. But, I kept a lookout. I didn't want that Indian woman slipping up on me. I told my Maw maw about the screams and she assured me the sound was not a haint. But, what she told me scared me even more. She explained the sound was being made by a "painter." She said, "I'm not sure the color of this big cat. Could be he is brown. But, he is probably black with green eyes." She further explained that these black panthers were mean and sneaky. They had been known to kill humans. She told me it was best that I stay inside for the rest of the evening

One thing he did tell me is this. He tried to inform the pedestrians that there is a Georgia state law that says, and I'm quot-ing my friend, "You can walk on any public road in the state, with the exception of an Interstate Hwy, as long as you walk on the left side of the road facing traffic." My buddy is a smart guy, and I know he's walked for exercise around Blairsville and other areas of our state for many years. I decided to see if he was correct about that state law, and what I've found is 2010 Georgia Code 40-6-96 - Pedestrians on or Along Roadway. Now, that law doesn't say exactly what my friend said it did, but Section D does state this, and I quote: "Where neither a sidewalk nor a shoulder is available, any pedestrian standing or striding along and upon a highway shall stand or stride as near as practicable to an outside edge of the roadway, and, if on a two-lane roadway, shall stand or stride only on the left side of the roadway." These pedestrians were on a two-lane road at the time this altercation happened, and since they were on the righthand side of the road, THEY

were in violation of the law. We have so many NEW people moving up here. More and more of them will be using our roadways for exercise. A lot of them don't take the time or effort to find these things out for themselves before they put themselves in that dangerous position. Don't get me wrong, there are also a lot of Georgia natives that don't know the law. As far as my friend being accused of speeding by the pedestrians, he was coming up a hill. Anyone who understands how

vehicle engines work knows that an engine under the load of pushing the weight of that vehicle up a hill is going to sound like the vehicle is going faster than it is because the engine is under a load and working harder. Yes, it's as simple as that.

The last thing I have to say about this is, if you don't know whether what you're doing is or isn't against the law, the best course of action is to NOT do that thing until you clearly find out and understand what the actual law says.

longer if left on the vine, and you can still eat them if they're big, but they get tougher as they age. You should be able to push your fingernail into the skin.

Sweet corn is ripe when you can puncture a kernel with your fingernail and milky fluid comes out. As soon as corn is picked, it starts to lose flavor. Refrigerate it to retain flavor.

Pick peas when the pods have plumped out. If they start to wrinkle, they're getting overripe. You can always open a pod to see if the seeds are swollen, but still tender. Beans are ready when you can see the seeds bulging through the sides of the pod.

Pick peppers when they are shiny green. If you let them sit on the bush longer and they start to change to orange or red and they're getting hotter. If that's what you're looking for, let them sit.
