MIT FOR HARBOR COVE MARINA LOCATED ON HIWASSEE LAKE, CHEROKEE COUNTY, NORTH CAROLINA

The USDA Forest Service, Nantahala National Forest, Tusquitee Ranger District is considering a request from The Dam Boat Dock LLC, dba as Harbor Cove Marina, for a renewal of a special use permit to operate on National Forest land on the northwest side of Hiwassee Lake. Harbor Cove Marina has had a Forest Service permit at this location since 1974 and would like to renew it for ten years. The marina is located in a cove across from the Bear Paw community and serves watercraft owners from North Carolina and Georgia. The marina is permitted to occupy 1.6 acres of the Na-tional Forest land above the high water mark of the shore of Hiwassee Lake. Improvements on the National Forest include a six hundred foot gravel access road; a one hundred gallon metal fuel tank; a mobile utility trailer used for an office, maintenance, and selling light food snacks; electric power (poles, lights, wire); a portable toilet; a concrete boat ramp, and a wood and metal foot ramp for access to cov-ered watercraft slips. The marina has a Tennessee Valley Authority 26a permit and currently has sixty covered watercraft slips, and is permitted by them to have up to ninety slips. No floating cabins are permitted to be moored or rented at the marina. Vehicle parking is on adjacent private land. No additional improve-ments are planned at this time, and any future improvements would need to go through the normal legally required environmental review. The USDA Forest Service is interested in receiving comments regarding the renewal action's potential to affect the environment or historical properties, and to identify any other issues associated with this renewal. Any comments received, including names and ad-dresses, will become part of the administrative record and will be available for public inspection.
