Commissioner Lamar Paris to get one, but with limited have committed to helping with took to Facebook on Thursday, Feb. 18, to notify people about the shipment being delayed due to weather issues, and he reassured residents with appointments that they will have access to their vaccines.

"Please remember to bring your vaccination card," Paris said. "We are very sorry and disappointed for the inconvenience. If for some reason you cannot make (Feb. 26), please call our local Health Department at 706-745-6292. You could try this week or early next week."

Regular Health Department vaccination appointments are ongoing thanks to locally stored supplies, with the mass clinic having been interrupted due to the large supply needed to host the event, Public Health Information Officer Dave Palmer said.

And Union County is not alone in the interruption; vaccination efforts across the country have been impacted by the delay. Fortunately, COVID numbers everywhere seem to be declining, including at the local hospital.

"We still are pushing the mitigations - wearing the masks, social distancing trying to limit the spread," Palmer said. "I think all of that is working because the number of cases have gone down, and we don't have enough vaccine in people yet for the vaccine to be limiting the spread."

Early vaccination efforts are still focused on medical workers; long-term care residents and staff; all Georgians 65 years of age and other first responders

vaccine supplies persisting for the time being, a phased allocation remains necessary.

Even though Public

Health is not actively taking new appointments for COVID-19 vaccination due to this limited availability, people trying for an appointment with the Health Department should continue checking the phdistrict2.org sign-up portal.

Alternatively, people can call 770-531-5692 to check on appointment availability, and if someone doesn't answer, keep calling back, as demand has greatly impacted the district's ability to get to all callers immediately.

Additionally, to take advantage of further collaborative mass vaccine efforts between the Union County Government and the Health Department, be sure to check in regularly with unioncountyga.gov to see when new appointments come online as supplies become available.

People should be aware that anti-inflammatory medicines may depress immune responses to vaccination, which is why District 2 Public Health says folks should avoid them unless needed.

"We recommend that people do not take antiinflammatory drugs before vaccination unless it is part of their routine treatment for other conditions," Palmer said previously. "Also avoid after vaccination unless necessary for the control of fever or pain or is part of their routine treatment for other conditions.

' A c e t a m i n o p h e n use is preferred over antiinflammatory medications such as ibuprofen.

In his January meeting, Paris declared Union to be a county that supports and protects the Second Amendment. While this was welcome news for attendees, several had concerns that the resolution did not specifically declare Union County a "Second Amendment Sanctuary."

After considering all feedback, Paris decided to amend the language of the resolution to include this sought-after change, which he discussed in the Feb. 18 meeting.

The following wording will be added to the resolution," Paris said. "Be it further resolved that Union County opposes any efforts at the state or federal level that would prohibit Union County claiming to be a Second Amendment Sanctuary or any enforcement related thereto.'

"It turns out they were not stored here, and because of the extreme winter weather in all transportation quarters throughout the U.S., supplies have not been received by Public Health. They will be delivered on Tuesday (Feb.

The second dose of the Moderna vaccine is supposed to be administered at least 28 days after the first, though the Centers for Disease Control and Prevention advise that efficacy of the two-shot vaccine should not be impacted if the second dose is received within 42 days of initial vaccination.

Also in the meeting, Paris highlighted some small projects the community may have noticed around Meeks Park, including a new restroom above the Sorghum Festival Field and a new pavilion being put up in place of Pavilion 3 located by the two ballfields in
