# Hunter sets program scoring record, lifts Lady Panthers into Sweet 16

Seventh-ranked Laney ousts Union County behind a 50-point second half

The Union County (13-14) women's season came to a close last week during the second round of the Class AA State Tournament following a 54-49 Tuesday victory at Columbia and an 81-58 Saturday loss to

In the win over Columbia, senior Ava Hunter scored 27 points to become the Lady Panthers' all-time leading scorer, passing 2009 graduate Candace Williams.

Entering the Tuesday, Feb. 22 contest, Hunter needed 26 points to equal Williams' career scoring mark of 1,601 points and she stormed out of the gates with a 19-point first half. The University of North Georgia signee eventually broke the record with a late free throw that helped Union County fend off a furious Columbia rally.

Lady Panthers 54, Co**lumbia 49 -** Union County jumped out to a 19-point lead then held on for dear life down the stretch during their 54-49 first-round victory at top-seeded Columbia (21-7) in Decatur.

Ahead 30-17 at halftime, the Lady Panthers opened the third with a 6-0 spurt to build their largest lead of the night at 36-17 with under seven minutes left in the frame. But the Eagles began chipping away, picking up the pressure defensively and narrowing the margin to 42-29 at quarter's end.

"We got out of rhythm and got into a running game [in the second half] which we didn't want to do," Union County head coach Mandy Hunter said. "[Columbia] started picking us up a little higher, making it harder for

Ava Hunter hit 1 of 2 at the line to begin the fourth, giving her squad a 43-29 lead while three points of tying the scoring record. Four straight from the home team made it a single-digit game with 5:16 remaining, but Ava Hunter connected on two more free throws a minute later, extending the margin back to

Clinging to a 50-40 advantage with 2:52 left, the Lady Panthers were on the verge of clinching their second Sweet-16 berth in three years when freshman point guard Ariel McCarter picked up her fifth foul, leaving Union County with a shortage of ball-handlers against a physical, attacking defense.

It was so hot in [the gym]," Coach Hunter said. "We pressed

them off and on but we weren't getting the calls at all in the second half. [Columbia was] all moving the senior post within over our guards the whole way

With under 90 seconds remaining, the Eagles clawed to within four at 50-46 when Ava Hunter broke the record by hitting two free throws at the 1:20 mark.

Columbia would eventually whittle the Union lead to 52-49 with six seconds left, but that's as close as they would get thanks to timely foul shooting from the Lady Panthers, who hit 10 of 14 down the stretch to secure the victory.

Senior Rebekah Chambers went 2 of 2 at the line over the final frame and ended her night with 10 points. Sophomore Lara Turner added 6 points, and Mc-Carter hit three fourth-quarter free throws to finish with 5 points. Sophomore Kamryn Mull made 1 of 2 at the charity stripe in the fourth and ended with 3 points. Junior Corinne Hill also chipped in 3 points.

7 Laney 81 - Union County wasn't as fortunate during the second half in Saturday's visit to seventh-ranked Laney (Augusta), surrendering 50 points over the final 16 minutes of its 81-53 Sweet-16 loss.

The Lady Panthers fell into a 22-9 hole after one but man, a sophomore and a junior

battled their way into contention behind 11 second-quarter from Ava Hunter, moving Union County within five at 31-26 at the break. The Lady Panthers started the second with an 11-3 run as Turner and Chambers got in on the Union rally that ended with the visitors outscoring Laney 17-8 during the frame.

Ava Hunter, Chambers and Turner combined for 16 of the Lady Panthers' 18 thirdquarter points but Laney's offense proved too overpowering, eventually pulling away at 60-44 entering the fourth.

Union County would allow 21 points in the final frame as Laney's 50 second-half points marked the most allowed by a Lady Panthers' team during the second half in at least a decade.

Despite leaving seven points at the charity stripe on Saturday, Hunter finished with her second-straight 27-point outing, giving her 113 points in Union's four postseason games.

Turner poured in 13 points eight coming after halftime. McCarter scored eight of her 10 points during the second half and Chambers added 8 points before fouling out in the fourth.

The Lady Panthers graduate their top two performers in the post: Chambers and Ava Hunter. However, Union County remains a young program with a fresh-

### Panthers and Lions' postseason thriller marred by controversial officiating

The Union County men closed out the 2021-22 season with a spirited homecourt effort, but in the end, they couldn't overcome foul trouble, ejections and a 44-point performance during last Wednesday's 75-62 first-round exit at the hands of private-school power Lovett.

The Panthers scored the game's first six points en route to a 19-8 lead after one quarter. Union County's margin expanded to 24-11 before two fouls apiece on Houston Henry and Caleb John helped the Lions close the half with a 13-3 run, slicing their deficit to 27-24 at the break.

Lovett's first lead of the night came at the 3:06 mark of the third when a Panthers' turnover resulted in a 39-38 score. However, Union raced ahead via an 11-5 stretch that opened up a 49-44 cushion with 7:31

But the Lions answered back with a 3-pointer and things quickly turned south for the Panthers as Landon Kight immediately picked up his fourth foul and head coach Corey Garrett was sent to the locker room moments later for disagreeing with an offensive foul.

Following the ensuing four free throws and possession, Lovett took control, up 58-49 at the quarter's midway point. Landon Kight scored Union's next four points, all coming at the charity stripe, keeping his team within seven at 60-53. Another Kight free throw at the 1:33 mark kept hope alive, down 62-54, but Lovett hit eight straight free throws to put the Panthers away

Kight led Union County in his final game, notching a teamhigh 25 points and a game-high seven rebounds while hitting 7 of 11 from the floor and 1 of 3 from 3-point range. Meanwhile, Lovett's Christian Anderson went off following a quiet first quarter that saw the University of Michigan commit score just 2 points during the opening frame. Anderson finished the game with 44 points on 13of-19 shooting and 17 of 18 at the charity stripe. Kyle Walters added 22 points and six boards on 7-for-15 shooting while the rest of the team combined for 9 points and two assists on 4 of 12

Panthers' freshman Jude Ellis chipped in 12 points, a

game-high four assists and a team-best two steals.

Ellis opened the scoring with a pull-up jumper before drilling a pair of first-quarter 3s -- the second trey spotting Union County a 16-6 advantage. The period closed with a bang as Kight knocked down a transition 3 from the top of the circle during the final minute, whipping the home crowd into a frenzy

The Panthers were limited to just eight in the second quarter as seniors Lake Hughes and Austin Taylor each connected from 3-point territory. With Union leading 19-11, Hughes answered a Lovett trey with corner-3, then Kight hit two free throws that awarded the Panthers their largest lead of the game -- 24-11 at the 4:37 mark of the second.

As the Lions polished off a 10-0 run that narrowed the gap to 24-21, Taylor sank a 3 from the wing, extending the margin to 27-21 just shy of the first half's one-minute mark. But Lovett responded with consecutive buckets from Anderson, including a buzzer-beating dribble-drive that narrowed the Union advantage to 27-25 at the break.

The Lions opened a tightly-contested third frame with a Henry's ankle-breaking crossgame-tying basket -- knotting the score for the first time since 0-0. But Union County went back to its seniors with a 3 from Taylor and a deuce by Kight to hand the Panthers a 32-27 cushion. A baseline drive from Ellis and a pair of Kight free throws kept the margin at five as the clock ticked free throws and the Panthers under five minutes.

Ahead 36-35, Kight went back to work in the post for a 38-35 Union advantage with 3:45 left in the period, but Lovett scored on consecutive trips to secure its first lead at 39-38.

John countered by attacking the rim and drawing a foul, resulting in a 3-point play and a 41-39 score. Thirty seconds later, Henry canceled an Anderson goahead trey with a 3-ball of his own, putting Union up 44-42 at the 2:20 mark.

Although, it's worth noting that Anderson's 3 was originally ruled a 2-point basket before it was overruled by another referee despite video footage later revealing a toe on the line.

Tied at 44-44 after three quarters, Henry opened the fourth quarter with a highlight reel moment via another 3-point basket, this one coming at the expense of the Atlanta privateschooler attempting to shadow the third-generation Panther.

Henry's triple dropped after he crossed up a Lovett guard on the wing, then proceeded to hit a step-back trey with his defender sprawled out on the floor courtesy of the freshman's tight handles.

To add insult to injury, over took place directly in front of an exhilarated UCHS student section, which resulted in the Lions' defender taking his frustrations out on the nearby official, consequently leading to a Lovett technical foul.

Ellis hit both technical were back on top by five at 49-



44. However, the home crowd would be silenced by Anderson's Herculean performance down the stretch, beginning with a 10-0 run that was punctuated by Garrett's ejection at the 4-minute

After playing it cool all night in the face of an endless string of (what an exceptionally generous person would refer to as) questionable calls, the Union coach finally had enough.

The ejection came as Garrett voiced his frustration on the heels of a spiteful offensive foul as Lovett attempted to get physical with the Union backcourt on the perimeter. And as Garrett pointed out a potential Lovett foul, he was awarded with an immediate whistle.

But it wasn't the call he was looking for.

Instead of a violation against Lovett, the official decided to inflame the situation by hitting Taylor with a ticky-tack push-off after setting a screen away from the ball.

As Garrett voiced his disagreement with the blatantly antagonistic call, he received his first technical foul, followed by another T seconds later.

Lovett used the ensuing four free throws and change of possession to open up a 58-49 lead before going on to win

Taylor finished with 9 points and two assists; Henry had 6 points and three assists. John scored 5 points with five boards while Daniel Snow pulled down

one rebound. Lovett hit 24 of 46 (52%) from the floor and 24 of 32 (75%) at the line, but sank just 3 of 15 (20%) from deep. Union County made 20-of-46 (41%) overall, 9 of 23 (39%) from long distance and 13 of 16 (81%) from the charity stripe.

The Panthers won the rebound battle 26-22 but were outscored 30-22 in the paint. Lovett turned it over just seven times while forcing Union into



points, four rebounds and a steal comes to a close at 12-14, but the Panthers ended on a high note after sporting a 3-7 mark in mid December.

The Panthers will return a pair of all-region honorable mentions in Ellis and Henry, along with a key post contributor in Eli Underwood and bench spark plug Braylen Rader. Additionally, a deep and skilled freshman class will be another year older in 2022-23 and could make up the bulk of the Panthers' rotation.
