According to a report issued by Civitas (civitas lonline. net), authored by Charles Gaba 2/17/17, the total number of people projected to lose coverage in Georgia, in the event of a full ACA Repeal, is 345,376 with 21,889 coming from the 9th Congressional District represented by Doug Collins. If lifetime limits, women's health care services, preventive care services, no discrimination based on preexisting conditions are repealed, all citizens, whether privately or government insured, will be negatively effected by this legislation.

Before reaching the age of Medicare eligibility, my husband and I, being self employed, purchased our own

source: health insurance. We poured thousands of dollars into a high deductible plan which assured us protection only in a catastrophic health emergency. We, fortunately, remained in good health and would have been wiser to have deposited that lost money into a bank account. It saddens me to think we may be returning to that unacceptable situation.

> Health care should not be a partisan issue. Congress must work as one to repair our broken system and make access to good health care available to all citizens. below the surface in their tunnels. Because they mainly feed on earthworms, which we actually want in our soil, you can't easily remove their food source to get them to move on their own. For this reason, trapping and killing is unfortunately the most effective way to resolve the issue.

For other animals that cause damage to your property such as beavers, groundhogs, squirrels, etc, there are licensed trappers in the area that can help get rid of any infestation. For more information on trappers and how to get rid of nuisance wildlife, contact your extension office.

It is standard for PPE to have an operational life of 10 years. PPE is inspected and tested annually for wear and effectiveness. Any PPE that fails inspection or testing can no longer be used by the

firefighter. Fires and accident scenes present environments that are hazardous to firefighters. Utilizing the full set of PPE, consisting of the turnout and SCBA, the firefighter can safely work in these environments and rescue others during an emergency.
