Tabletop Exercise

A couple weeks ago, we published a column about the di-saster workshops that were conducted by Union County Emergency Management Agency (EMA). These workshops were part of an exercise cycle that centered around a school bus accident and they involved many other organizations and partners within Union County. The workshops were designed to discuss

a scenario, discover possible issues, and create policies or procedures for dealing with a major school bus accident in our community. The exercise cycle ended with a tabletop exercise that was designed to test the created policies and procedures that were developed in the workshops.



Union County EMA hosted the tabletop exercise on Thursday, March 24th. The participants were divided into groups based on discipline or function. Next, they were provided with "resources" which were represented by small colored magnets. These resources were the various units, vehicles, and personnel that the participants were to use in the scenario. The magnets were used to place on the maps of the various locations discussed in the tabletop. This provided a visual way for participants to track resources.

The exercise began with an explanation of the procedures. The scenario was then provided to the participants. They were presented with the basic information of a school bus accident that involved the bus being hit by another vehicle and rolling over resulting in multiple serious injuries, traffic issues, and public relations challenges.

Participants were given frequent updates as the scenario progressed as well as specific "inserts" of information that created issues. They would then apply the policies and procedures that would resolve these issues. Participants also had to communicate with other organizations to coordinate efforts. The scenario unfolded very quickly which placed time pressure on the participants due to the rapid amount of information and problems that had to be resolved.

Once the scenario was over, the participants discussed the lessons learned and the challenges of the scenario. They could then reinforce the policies that worked well and revise

Mystery Revealed

If you like mystery shows, the Poirot TV episodes based on Agatha Christie's novels is probably on your radar. British actor David Suchet played the title role from 1989 to 2013. During that time, he was trying to solve his own mystery.

In his book, "Behind the Lens," Suchet tells his story. He was enjoying his career as a successful actor. In 1986, he trav-

eled to America. In his hotel room soaking in a hot bath, his thoughts randomly settled on the afterlife and resurrection. That surprised him because until then he had been agnostic about such things.

He decided to read the Bible. Not knowing where to begin and

having some historical interest in the Roman Empire, he began in the letter to the Romans. Its probing truths attracted him. "If God is for us," it says, "who is against us?" "Who will separate us from the love of Christ?" (Rom. 8:31, 35). "I came across a passage," Suchet said, "that spoke of a way of life I wanted to be part of ... a coherent philosophy I could really relate to. Christianity offered me that. The Christian worldview is love.'

That hot bath in 1986 began Suchet's journey as a reluctant convert. He wasn't sure what to make of the resurrection of Christ. In 2007 after years of analysis, he found the evidence for the resurrection plausible and the way of faith veritable. Mystery solved. He believed in Jesus Christ.

Suchet is right to consider the physical, attested, bodily resurrection of Christ as central to the Christian faith. "The whole of Christianity is based not only on the death, the crucifixion, of Jesus, but also on the resurrection," he says. "The early Christians believed He was divine because of the resurrection and without the resurrection, there is no faith. You cannot separate the cross from the resurrection, which is the greatest miracle justifying Christian belief in Jesus' divinity." That's a good paraphrase of 1 Cor. 15.

The Bible connects Christ's love and resurrection. "Christ Jesus is He who died, yes, rather who was raised, who is at the right hand of God, who also intercedes for us." In a grand crescendo it declares that nothing, not even death, can separate us from the love of God which is in Christ Jesus our Lord (Rom.

Q. My neighbor mentioned a local cannery. Where is it located?

A. The Union County Cannery is located at the Farmer Market. It is a community cannery for home/personal canning only. The Union County Canning Plant is not certified for commercial use and products may not be sold. The address is 283 Farmers Market Way, Blairsville,

GA 30512. Anyone who would like to correspond electronically can email: cannery@uniongov.com Q. I would like to do some can-

ning. When is the Cannery open? A. For 2022, the Union County



Cannery is scheduled to open on July 5th and will be open Tuesdays and Thursdays from 6 a.m. - noon but only by appointment. Demand for the use of the Cannery is great. Appointments can be made by calling 706 439-6043 or by emailing cannery@uniongov.com. Appointments are scheduled in time slots of 6-8:45 a.m. and 9-11:45 a.m.

Q. What are the charges associated with using the facility?

A. The cannery charges 25ϕ per pint and 35ϕ per quart.

Q. What should I bring? Does the cannery provide

any hard supplies like jars, etc.? A. Visitors wishing to can fruits and vegetables should bring jars, lids, bands, products to be canned and all necessary ingredients needed for the canning recipe. The Cannery does have some bowls, knives, measuring cups, spoons, funnels, etc., but you are encouraged to bring your own.

Q. What procedures can I expect to follow when I arrive at the Union County Canning Plant?

A. Because there are a fixed number of prep stations, order and processes are very important to ensure all appointments are honored. a) Schedule your day/time by calling or emailing the Canning Plant.

b) Upon arrival on your scheduled day/time, complete the 2022 Registration Form. The first time you sign in, you will be assigned a number. You will use the same number each time you visit during the same year.

c) You may then go to your assigned table and begin preparing your product. If your product needs steaming/cooking, please let



Bear Wise

Black bears are becoming active again. While people enjoy having them around, it's important to remember that these animals are wild. Sometimes, when you see the bear time and again you may feel a personal connection to that bear. That feeling is probably not reciprocated. Interac-UGA tions with bears are inevitable to a cer-Watching tain level, so let's and Working talk about what to do if you see a Jacob Williams bear and the steps that you can take to make sure that your home doesn't become a playground for bears. Firstly, it's important to remember that we live in an area with copious amounts of national forest. That means black bears are out there. Hopefully, though if you encounter one you'll know what to do or how to make your space less attractive to them. Bears will typically live eight to 15 years. The females can weigh up to 300 pounds and the males over 500 pounds. The females will give birth in their den in late January. Those cubs will stay with the mother until the following spring when she kicks them out. Bears are omnivores meaning that they eat whatever is easily available depending on the time of year. Their natural diet is berries, fruits, acorns, grasses, insects, and even mammals. Bears can be attracted by the smell of human food if there is not much natural food available for them. Bears are naturally afraid of humans. However, bears that have been feeding on human food lose their natural fear of people, and become a danger. Bears will usually remain in an area where food is readily available, so the best way to make sure that bears don't move into your backyard is to remove the sources of food. Never feed bears either intentionally or unintentionally. They will learn where food is available and become a nuisance for you. Make sure that your garbage is in a place that they can't reach. That means leaving it inside the garage or if you're out camping hoisting your trash in the air or putting it in a bear proof trashcan. Bird feeders can attract bears because of the high calorie content in bird feed. Bring your bird feeders in when bears are active. Usually by the time bears are active there is plenty of natural food available for birds. Don't leave pet food out. Just give your outdoor pets enough food for one feeding. If you have a grill, clean and store it after use. Bears will be attracted by the smell of your grill so keep it out of reach for them. And finally, let your neighbors know if you see a bear so that See Williams, page 5A

My Papa Cummings told me one time that he'd moved from Dawsonville down toward Marietta. It must've been somewhere around Cumming that he began frequenting a bar. It was in this bar that he'd become involved in a quarrel with a man over a woman. The man was much larger than young Clifford, but that mattered not to him. The young lady's honor was in question, and my Great Grandfather beat the man mercilessly. It was so bad that he felt he'd killed his opponent.

Clifford left Cumming and fled back to his home in Dawsonville. Immediately, the authorities began looking for him. He was well-liked by his friends in Dawson County, and the Sheriff was well aware of his friend's problem. He told the young man, "I can tell them boys over in Cumming that I haven't seen you yet. But, if you are still around tomorrow, I know they'll expect me to arrest you. So, you better leave." He left and wound up in a little railroad town called Phil Campbell, in Alabama.

He met and married Effie Franks, living his whole life right outside of town in a community called Shady Grove. His youngest daughter was Glenna Mae. She eloped with my Papa at the age of 19, and Grand Daddy Clifford was so enraged upon hearing of the marriage that he refused to talk with them for nearly three months. Finally, he met up with Papa and said, "I thought you were a better man than to up and steal my daughter." To which Papa said, "Clifford, we were afraid to ask you." The old man thought for a minute and said, "You best treat her right."

a staff member know so they can cook/steam your product and return it to you.

Q. How do we handle jars and lids?

A. Place jars upside down in small baskets for sterilization. Staff members will sterilize and return jars to you. You will write your registration number on the lids with a sharpie and then immerse your lids in hot water. You will place your product in the hot jars, put lids/bands on the jars, and signal a staff member. Your jars will be processed for you. Q. Once everything is in jars, do I leave?

A. Clean the table and any Canning Plant equipment used before leaving. Take your personal things with you. Return after the designated time to pick up and pay for your product. Place the exact amount inside the envelope, seal, and place in the collection box. You can then take your processed product home.

There is always someone on site to assist if necessary. We hope you enjoy using the Union County Cannery.

they can take precautions too.

Most bears are not aggressive, unless they have been fed by humans before. Bear relocation is usually not an effective control option. Bears that are relocated might be moved to an area that another bear has already claimed, leading to territory fights, or the bear may try to return to its home and be struck by a vehicle. Relocation is a last resort.

If you do encounter a bear in the open make yourself look big and wave your arms and shout while backing away slowly. Do not get between a mother bear and her cubs. If you are attacked fight back aggressively with anything you can get your hands on. Bears can be dangerous but know that there are no recorded fatalities in Georgia.

He would then look at old Doc and exclaim, "Doc, you get your cheating self out of here and don't come back unless you turn honest." His friend would slowly rise from his seat and walk toward the door with a laugh and respond,

"I'll see you next Thursday, Clifford". My great-grandfather expected to win each and every game and never learned to be a good loser. Each Saturday morning he would always walk down to Isom's Store and

buy a new box of Dominoes. He probably spent a small fortune on Dominoes during his life. He lived until he was 96 and continued to play Dominoes every Thursday with Doc Underwood.

In the County's Short Term Work Plan (STWP) to the Department of Community Affairs, it said: Expand Jail, Postponed due to Lack of Funding. The Solid Waste Transfer Station, Postponed due to Lack of Funding, Lower Priority. The report then shows these two projects will be done in 2016. Neither project was done in 2016.

In the March 29 meeting, the County Commissioner insisted that what we say about the Jail and Transfer Station is false, that he did not abandon any SPLOST projects. That is not true. The facts tell us that these projects were abandoned. The Jail was NEVER expanded, and it's taking SPLOST 4 and now SPLOST 5 money to finish the Transfer Station.

The reason for this letter to the editor is to tell the truth about how our taxpayer money is being spent (OR NOT). It would be nice if our elected officials would not say that we are creating a false narrative by stating facts which are being obtained by Open Records Request so that we can see what the truth is. **Cindy Vandereedt Concerned Citizen**
