Telecommunicators Week

National Public Safety Telecommunicators Week - During the week of April 14th through the 20th, the Union County 911 Center is celebrating National Public Safety Telecommunicators Week. This week honors the thousands of men and women who respond to emergency calls, dispatch emergency professionals and equipment, and render life-saving assistance to the world's citizens. It is a celebration of the 911 centers,

the dispatchers, and their vital role in public and community safety. When an emergency strikes,

people want to know that they can call for help. They want someone to answer the call. That someone is a Public Safety Telecommunicator, more com-



monly known as a 911 dispatcher. Every day, 911 dispatchers receive various emergency calls and dispatch the appropriate units to deal with these calls. Callers want that 911 dispatcher to be calm, professional, confident, and efficient. They want that 911 dispatcher to reassure them that help is on the way. Being a 911 dispatcher is one of the most unique jobs in pub-

lic safety. They answer the emergency call, determine the nature of the emergency, determine who or what should be sent to the emergency, dispatch units to the scene, and record everything in the computer-aided dispatch system. 911 dispatchers are experts at staying calm and keeping the

caller calm. They are also skilled in gaining information from excited or even frantic callers who, at times, provide limited information. The most amazing and unique skill that dispatchers have is the ability to multi-task. At times, that may be talking on the radio, listening to a caller, typing, looking at the computer mapping system and sharing information with other dispatchers all at the same time. It truly takes a special person to be a 911 dispatcher. The 911 dispatcher is one of the most unsung heroes of pub-

lic safety. They are the initial point where the emergency is received and communicated. They are the calm voice on the phone when someone calls 911 on what could be the worst day of that person's life. The dispatcher is not as visible as other public safety professionals, but you can rest assured that they will always be there. Take the time to thank a 911 dispatcher.

Your Story

Chris Coghlan was 15 when it happened. It was 2001. He had just finished exams for his sophomore year. He arrived home to a gathering of cars and people. He stepped inside, joking about a party in his honor. Then he saw his mom's face. His dad had been killed in a head-on collision. Coghlan was overcome with anger and grief. His mom

called Randy Holland and Roy Silver. Coghlan had been attending their Christian-based baseball academy in Clearwater, FL. They canceled training for the day and rushed to the Coghlan home. Over the ensuing years, they were father figures to the



Baseball became Coghlan's coping mechanism. He would practice late into the evening to avoid the depressing effect of going home. The extra work paid off. He received a baseball scholarship from Ole Miss, where he earned All-SEC honors. But he was ignoring the values his dad had taught him. "I could do whatever I wanted," he said, "because I had the best excuse."

He was a first-round pick of the Florida Marlins. When they called him up from the minors, he only lasted one day in big league training camp. He partied hard the night before, and it showed. Being sent down "is an empty feeling," he said. "I was completely selfish.

Back at minor league camp, he noticed Darren Roberts reading the Bible in the clubhouse. They talked briefly. Later on the practice field, Roberts mystified Coghlan with an unusual gesture of kindness. After practice, the two men met for coffee. Roberts asked, "Are you a man of faith?" and explained what he meant. "By grace you have been saved through faith; and that not of yourselves, it is the gift of God" (Eph. 2:8). Coghlan explains what happened next. "I realized that I wanted Jesus in my life. I was tired of chasing the wind. I was trying to fill the void with baseball. I was a miserable person. After he shared that with me, I accepted Jesus

God in His providence, foresees and uses the story of your life to reveal His love and care to you and others. "In your book were all written the days that were ordained for me" (Psa. 139:16). Your chapters may identify with Coghlan's tragedy, or Holland and

Commissioner's Questions

This week's questions and answers focus on Probate Court. Dwain Brackett serves as the Probate Judge, and Kristin Stanley serves as the Associate Probate Judge. These questions contain general information, and if you have further questions, you can call their office at (706) 439-6006, visit their website at www. unioncountyga.gov/probate, or visit their office at 65 Courthouse Street, Blairsville.

Q. How do I get a marriage

A. To obtain a marriage license, both parties must appear in the Probate Judge's office to complete a written application, or they may submit an online application before com-



ing in. Both parties must be at least 18 years of age and provide a form of identification. If either party has been married before, proof of the dissolution of the previous marriage is required. If at least one application is a resident of Georgia, the parties may apply for their marriage license in any county in the state of Georgia. The cost is \$26.00 with a certificate of pre-marital education or \$66.00 without pre-marital education. The court accepts cash, local checks, money orders, and credit cards. More detailed information is available on the Probate Court website.

Q. Where can I get a copy of my marriage license?

A. Copies of marriage licenses must be obtained from the Probate Court in the county where the license was applied for. The cost is \$10.00 per certified copy.

Q. Where do I get a Georgia Weapons Carry License?

A. Probate Court handles the issuance of Weapons Carry Licenses in Georgia. The applicant must be at least 21 years of age, a resident of Union County, and must provide a picture ID with a physical address. If the ID has a P.O. Box, the applicant must provide proof of their physical address. New applicants must submit a written or online application with Probate Court, and then submit to a fingerprint-based background check at the Union County Jail. The fee for new applicants is \$78.25. The license is valid for 5 years. Renewal applications can be made within 90 days prior or up to 30 days after the expiration date of the license. The renewal fee is \$30.00



Blooming Trees

Oftentimes when we talk about pollinator plants we think of annual flowers or shrubs that produce a lot of blooms, but if you have the space there are some trees that have spectacular blooms and are beneficial to pollinators. A lot of these trees bloom early in the year, which is a

good thing. Many of the other pollinator plants are not flowering yet early in the spring and these trees provide a crucial food source for our pollinators.



Let's start with poplar trees. They are not always thought of as pollinator plants, but they

contain a lot of nectar and pollen. The blooms are high up in the tree. They also have green petals with an orange band. This makes the flowers blend in with the rest of the tree and hard to see. Poplars are usually among the first hardwoods to start growing after an area has been cleared. Because of this you'll sometimes see a lot of them growing together. Some people don't care for them, because they are so abundant, but don't forget about their value to pollinators. Dogwoods are very common, but there are

several different species of them. Cornus florida is one of our native dogwoods. The wild ones tend to have smaller blooms than cultivars you buy commercially. Kousa dogwoods have large attractive flowers, and they tend to bloom a bit later than our native dogwoods. Silky dogwood is a beautiful native dogwood that has small blooms. but in large clusters. They also make great trees for planting along streambank or wet spots because they like wet soil. You may hear old timers talk about dogwood winter. This refers to when we have a cold snap while dogwoods are blooming. Blackberry winter comes after dogwood winter, if you have a cold snap while blackberries are

Redbuds are another common flowering tree. Their blooms are a bit more lavender than red in my opinion. I think that redbuds blooming in conjunction with dogwoods are beautiful. The parking lot at the Mountain Fairgrounds are a great example of that. Some people don't like redbuds because they do tend to drop a lot of branches. But when they are in full bloom you can hear the tree buzzing with bees.

Black Cherry is our wild cherry tree. These blooms are small and white. They produce small fruit in the summer that wildlife can use, but they are so small they are not great for human consumption. It is a host plant for the tiger swallowtail, which is our Georgia state butterfly.

American fringetree is not nearly as common as any of these other trees but it is one of my favorites. The flowers have long lace like petals.
