### **Summer Safety Considerations**

The warm temperatures are here and it's the time of year that everyone wants to get out and enjoy some summer adventures. Unfortunately, some of those adventures can lead to accidents and injuries. At the beginning of each summer, we provide some safety tips and considerations for summer activities to promote safety.

Swimming is a favorite summer activity and no matter if you

are on the lake or sitting at the pool, it's a good idea to practice these swimming safety tips. Never leave young children alone when swimming; always have an adult present. Although we want to have fun, running and horse playing is dangerous around a pool so no running or swimming stunts.



Swimmers should also be aware of water depth and not dive in shallow water. Have safety equipment and flotation devices near the pool or swimming area for emergencies. If there is an incident, you want to be prepared. A CPR class could provide lifesaving information and skills to help if an incident occurs. Another activity of the summer that may cause accidents is

riding motorcycles and ATVs. These activities can be fun, but they can also be dangerous. Always wear your safety gear. Helmets are a must. Head injuries are a leading cause of death from motorcycle accidents. Use caution on rough and steep terrain. Never operate a motorcycle or ATV under the influence of drugs or alcohol. Hiking is another summer activity, but you must be prepared.

Plan your hiking route and take a map, if possible, do not rely on your cell phone. Water and snacks are a must. Hikers should dress for the terrain with good hiking boots and proper clothing. Take extra clothing and a flashlight just in case it gets dark before you get back to your vehicle. Probably the most important is to never hike alone and know your limitations. The summer sun can be dangerous no matter what activity

you prefer. Keep cool by staying out of the sun as much as possible. Stay hydrated with water and avoid other drinks that may cause more harm than good. Wear sunscreen, skin cancer is real. Every moment that you expose your skin without sunscreen increases your risk. Even on partly cloudy days, sunburn is possible.

### **Agriculture Laws**

Today I want to talk about some new laws regarding agriculture in Georgia. These laws either came out this year or last year. The purpose of me discussing these laws is to make people aware of them. The purpose is not to give anyone legal advice or to state whether I agree

or disagree. I just want people to be aware of some of the legislation that has passed into law and the reasoning behind why it was



One bill that was signed into law last year



is regarding bee removal from a structure. Basically, this law requires individuals who remove honeybees that are ensconced in a structure to be licensed. The licensing is overseen by the Georgia Department of Agriculture. If the honeybees are free hanging on a tree or on the side of a building you do not need a license to remove them. If they are inside a wall or a cavity inside the structure, then a license is required. In the past people would call a local beekeeper to remove the colony. However, there have been situations where extensive damage has been done to homes, because removal was not done properly or ethically. The goal of the licensing process is to eliminate that issue. Currently, neighboring states don't have laws like Georgia does regarding honeybee removal. However, it is expected that within the next few years they will and some reciprocity of licensing will be established. Right now, we are in an awkward stage because this has been signed into law, but there are very few licensed honeybee removers in the state. Georgia Department of Agriculture is working to get people licensed, so we are in a grace period. The law can be found in Chapter 620-9 of Rules and Regulations of the State of Georgia. This law only applies to honeybees. It does not apply to other species of bees, wasps, hornets, or yellowjackets.

A law that was passed this year is regarding elementary agriculture education. Middle and high school students can take agriculture classes already. Starting this fall any local board of education can begin to offer agricultural classes if they so choose. Elementary agriculture classes and teachers would be funded by the local board of education. There was a pilot program for elementary agriculture education that started in 2018 which had 27 schools participate. The goal of elementary agriculture education is to increase agriculture literacy so that people understand where their food comes from. This was

House Bill 1303. The last bit of legislative work that I would like to talk about is what people call the

#### How to comply with Georgia's new **Outdoor Burning Laws!**

We have preached about always get a permit to burn anything even a small pile of

This is protection for you in case disaster strikes and the fire escapes and burns things it is not supposed to. It also gives emergency dispatchers



information on where legal burns are taking place so they don't dispatch fire trucks unnecessarily to put out your controlled fire.

Now there is a new law on the books in Georgia as of July 1 that removes the requirement for a permit for small piles of debris, but it puts more responsibility on you to do things to comply with this new law to make the burn safer. If the fire gets out and help is dispatched and you are not in compliance with the law, then fines may be imposed to pay for the suppression costs, such as bulldozers, firefighters, engines, and you don't want to know what a helicopter or air tanker costs!

So do what the law requires and you should be covered in case your fire escapes onto your neighbors property. You can learn about Georgia's revised outdoor burning regulations and how to "Take Five" before burning; providing an easy five-point "S-S-T-A-R," to visually remember your responsibilities as

As of July 1, 2021, changes go into effect regarding the legal responsibilities of Georgia landowners burning outdoor yard debris. Under Senate Bill 119, GA code section 12-6-90 was changed to eliminate the need to notify the Georgia Forestry Commission (GFC) by the person, firm, corporation, or association who intends to burn hand-piled natural vegetation/ yard debris. Any local burning ordinances are applicable and may be more restrictive than state law. In addition, restrictions on burning in 54 northern Georgia counties under the Environmental Protection Division summer burn ban from May 1-September 30 continue to be in effect. Changes to 12-6-90 include specific requirements of those intending to burn out-

munication campaign is informing landowners of these requirements in various media and is built on an acronym that emphasizes legal burning responsibilities. It advises burners to carefully plan their burn by remembering to "Take Five," and follow an easy to remember; "S-S-T-A-R" formula: S - Space - 25+ feet between fire and woodlands; S - Space 50+ feet between fire and structures; T – Time - sunrise to sunset; A - Attendance – Person responsible on-site until the fire is extinguished; R – Reasonable precautions – Tools/measures in place to prevent escaped fire.

Beginning May 1st and ending September 30th, EPD's Open Burning Ban will be enforced in 54 Georgia counties. The Open Burning Ban prohibits citizens and businesses from burning yard and land-clearing debris. This rule is in addition to the year-round state ban on the burning of household garbage. Open burn rules in Georgia don't restrict you from never making a fire outdoors.

There are several legal ways to burn outdoors; thirteen ways in fact. These are types of legal burn activities as outlined by the Georgia Environmental Protection Division: 1. Reduction of leaves

on premises, 2. Agricultural procedures for production or harvesting of crops (if land tract is 5 acres or less), 3. Burning vegetative material for agricultural operations (if land tract is greater than 5 acres), 4. Prescribed burning, 5. Recreational purposes and cooking, 6. Firefighting training, 7. Acquired structure burns, 8. Vegetative debris from storms, 9. Weed abatement, disease, and pest prevention, 10. Open flame devices, 11. Land clearing, construction, and right-ofway maintenance, 12. Disposal of packaging materials for explosives, and 13. Land clearing with an air curtain destructor. And though these are legal ways to burn in Georgia, some of these types of burning require permits or special equipment.

Burning man-made materials like tires, plastics, lumber, or household garbage is never legal in the state of Georgia

Freedom to Farm bill. This was House Bill 1150. All 50 states have some form of a freedom to farm bill or right to farm bill. The purpose of these bills is to protect farmers from nuisance lawsuits of smells, noises, or other legal practices related to farming. Georgia has had a freedom to farm law, but this new law strengthens it. One of the big changes that this law presents is that lawsuits must be brought by individuals who live adjacent to the farm. The

other change is that the lawsuit must be brought within two years of the act that it is about. The reason for the changes to Georgia's right to farm bill was to protect farmers from nuisance lawsuits. An example is lawsuits that shut down a hog operation in North Carolina in 2020.

McMurray was very professional. However, his right hand which was keeping time sped up and instead of being in 1/4 time the song was played in 3/4 time or maybe even faster. The whole situation is now a legend at Union Hill Church. Some even think it is not true. But, I was there.

An even earlier memory happened when I was 2 1/2. It was March in 1960 and we were visiting from up North. Actually, Mom and I had come home so my sister could be born. Mom knew the Doctor in Haleyville well and wanted him for her birth of my sister. We were sitting in Sunday morning service and the Preacher walked to the pulpit to begin his sermon. I was riled because I was not allowed to sit with my Papa. As scripture began to be read I found my chance. I left the pew in a hurry and ran to the "Amen Corner" where he was sitting. I figured I was safe there with him. I tried my best to remain still and quiet. And I was for maybe a minute. I eased to the end of the pew and Papa looked at me, so, I grabbed a hymnal and pretended to look at it. I made another break when he looked away. I dove under the pew and popped up in front and began playing hide and seek with the

Deacons. They were all laughing and I was having a good time until I noticed my Mom. She was coming for me, so I made a dash for the preacher. Soon the whole audience in the church was laughing, even the preacher, and I was the center of attention. Can you imagine what my Mom was thinking and feeling? Remember, she was 8 1/2 months pregnant and chasing this little kid across the stage at our little country church. After another mad dash around the stage, she grabbed my collar. I cannot remember what happened. All she'll say is that I never acted up in church again. And it was a long time before I was allowed to sit with my Papa.


