

New coach Scott Williams lays out plans for baseball program

Scott Williams will take the reins of Union County High School's baseball program following his approval during the Thursday, June 8 school board meeting.

Williams moves to UCHS following a one-year stint at Class 6A Lee County, where he served as the team's associate head coach.

Williams learned about the Union County opening through a friend at Lumpkin County, who informed him of the program's recent struggles along with its potential.

"A good friend of mine, Jonathan Gastley, who was at Mary Persons but is now at Lumpkin County, he gave my brother a call and told him the Union County job is open. He filled us in on what's been going on up there and said [Union] had a rough couple of seasons.

'From what I understand, they needed someone to come in and change the culture. They were looking for someone that wasn't close to retirement -- someone who would invest in the program.

"It seems to me that Union County, looking through its history, is much better than a three-win ball club. From what I can tell [about the returning talent], the baseball-end will take care of itself. The challenge is going to be changing the culture and getting everyone excited about baseball again. I don't know what kind of leadership

When asked about his plans for bringing a culture shift to Union County baseball, Williams answered, "I'm not coming up here to tell everyone, 'this is the way it's going to be.' But let's start over, get on the same page and build this thing the right way. If they take on that mentality and buy into that philosophy, then I think everyone will benefit from it. That's all you can do.

"They need someone to guide them through this. I've seen championship programs, been around some great coaches and seen how a championship program is run. And once you see that, you can spot the difference between players going through the motions and those playing to win a championship. The guys playing for championships do things a certain way, and hopefully we can impliment a few ber from when I was up there of those things.

they were under before, but ing things the right way, like I said, the baseball-end will take care of itself. Baseball skills are second-nature, I want to instill discipline, a philopsophy and a culture, and you should see a distinct difference after year one. I'm not saying we're going to be world beaters or we're going to change overnight, but you will see a considerable difference in the way things are done."

> As for on-field improvements in year one, Williams expects Union County to immediately compete for a playoff spot out of Region 8-AA.

> 'I'm pretty familiar with Class AA," he said. "I've seen the South Georgia powerhouses and been up against some of the [Class] AA Atlanta privateschool powerhouses, but they don't really scare me. If we do things the right way and find our identity early, I expect us to get into the playoffs. I want to compete in the region and let everyone know we are here. I want people to sleep on Union County. That's good for us because we'll sneak up on them.

ally taken aback. I'm used to watching these kids down here in south Georgia, so I was expecting to see a bunch of unathletic kids, but I watched [Union] play, and I realized they are pretty good. They way they handled the ball, and they way they got after it, they were athletes. You give me an athlete, and I'll teach them how to play baseball. You can't teach them how to be an athlete."

A 1999 graduate of Crisp County and a catcher by trade, Williams played his college ball at Georgia Southwestern before joining his brother Greg's staff at Lamar County in 2004.

In 2009, Scott Williams moved back home to Crisp County and spent a few years out of coaching when his alma mater came calling. As a member of the Crisp County staff, the Cougars featured a loaded squad that included current Tampa Bay Rays infielder Taylor Walls and future UGA standout Robert Tyler -- the 38th overall selection in the 2016 MLB Draft.

"I walked in my first day there, and I looked at coach [Bill] Pate and told him, 'you have a state championship-caliber pitching staff," he said. "You have [Tyler] throwing

said, 'I know, that's why I need your help.'

Crisp County advanced to one final four and finished as runner-up another year before the program took a slight downturn. However, Crisp remained a constant Sweet 16 and Elite 8 contender until Scott Williams ended up at Class AA Fitzgerald during the 2021-22 school year, where the Purple Hurricanes suffered a first-round sweep to Brantley County. He was also a member of Fitzgerald football's statetitle-winning coaching staff in 2021.

Scott Williams spent

a year at Fitz before joining a former college teammate, Wes Shiver, on the Lee County staff.

Lee County finished 19-13 overall and 9-6 in Region 1 during the spring, but the Trojans suffered a first-round elimination by Region 3's No. 2 seed Glynn Academy.

Scott Williams also spent time as the hitting and catching instructor for Team Elite South 17U.


When asked what it is about the Union County job that made the lifelong south Georgia native want to change to mountain-living, Scott Williams cited the encouragement he received from his daughter.

"I'm not with my daughter's mom anymore, and my daughter goes to school at Crisp, and I've turned down a few jobs in the last five or six years to stay close to my daughter," he said. "I went to Fitzgerald, and it was within driving distance, and Lee County was 45 minutes away.

"But when [the Union County] opportunity came along, I had to pray about it a lot. But when my daughter looked at me and said, 'go for it,' that was all I needed to hear. Also, you can't beat the scenery [in northeast Georgia]. It's God's country. I love it. Plus, my mom lives in Gatlinburg (Tennessee), so I thought this was a great opportunity."

Scott Williams will be in Blairsville this week and is meeting the baseball team at 1 p.m. Friday.

"I'm excited to get started and see a lot of potential," he said. "I'm grateful to have this opportunity and looking forward to being a part of the community.'



UCRD: 10U baseball to play for District 7 title; 12U finishes as runner-up

Last week, Union County's 12U baseball team placed second at Meeks Park's District 7 tournament, dropping two games to champion Lumpkin County

The 12U Panthers scored a 14-7 victory over White County in the opening round on Monday, June 5. The following day, Union County couldn't protect a late lead in a 14-8 loss to Lumpkin County but battled out of the loser's bracket with a 10-4 win vs. White County on June 7.

During the June 8 title game, Union County put up four in the first before surrendering 12-unanswered in a 12-4 loss to Lumpkin County.
