Vacation Fire Safety

Vacations are essential. Whether it be the beach, a mountain cabin or a trip, you want to relax and enjoy the time with family. Rarely do people think about fire safety when on vacation, but fire safety should be one of the first considerations. Union County Fire Department would like to remind everyone of some fire safety tips while on vacation to help provide an extra measure of safety.

One of the first things is a vehicle fire extinguisher. This is not only a good practice for long trips but also for everyday travel. You never know when you may have a car fire or if you come upon another driver with a car fire. The fire extinguisher should be automobile rated and secured in the



proper place. In the event of a fire, it can be used to put out a small fire before it engulfs the entire vehicle.

Once you have safely reached your destination, take a few minutes to check the fire safety of the building, cabin or home. Modern hotels have sprinkler systems. Make sure the sprinklers are not blocked or covered. Know the locations of the fire extinguishers and check the room to ensure that there are smoke alarms. When at an unfamiliar place, have an escape plan and a meeting place in case there is an evacuation of the hotel or building. The family may get separated or may be in different areas of the buildıng

If you are staying in a cabin or vacation home, make sure everyone knows the locations of fire extinguishers. Test the smoke alarms and replace batteries if needed. As you would do in your own home, have an escape plan with two ways out. Create a meeting place outside in the event of a fire. Know the address and directions to your location so units know where to find you.

Vacation homes and cabins usually have cooking areas and heating that may operate differently from your home units. You should educate yourself on the operation of the stove and the heating units and/or fireplaces. Make sure that they are operating properly and that they are turned off when you leave. The same advice can be applied to outside grills.

Jastrow's Logic

"In the beginning God created the heavens and the earth" (Gen. 1:1)

Or did he? Scientists in the 20th century assumed there must be another explanation for the origins of the universe. Many adopted the worldview of materialism, and believed it was their duty to relieve mankind of primitive notions about origins. That's

why Edwin Hubble's discovery of the red shift set many scientists on edge. They knew it had theistic implications.

The red shift indicated that stars are moving outward, expanding the universe. As physicist Robert Jastrow put it, imagine filming this



expansion, then running the film in reverse. Eventually all mass, energy, and space would be reduced to a finite singularity, i.e. a beginning called the big bang in popular parlance.

Jastrow founded NASA's Goddard Institute. He was agnostic about the existence of God. But he didn't mind pointing out the surprisingly theistic implications of the big bang. He calls it "an exceedingly strange development, unexpected by all but the theologians. For the scientist who has lived by his faith in the power of reason, the story ends like a bad dream. He has scaled the mountains of ignorance; he is about to conquer the highest peak; as he pulls himself over the final rock, he is greeted by a band of theologians who have been sitting there for centuries.

One of his contemporaries, Stephen Hawking, posited a mathematical explanation in the field of quantum cosmology as the cause of material world. Those who look for reasons to dismiss the God explanation put their faith in Hawking, who was no doubt a brilliant scientist. But Hawking himself identified the problem with his proofs. He asked, "What is it that breathes fire into the equations and makes a universe for them to describe?" In other words, equations do not create. He may have the right equation, and equations exist in minds. For quantum cosmology to have explanatory power, it needs a mind predating the material world. And that mind had to have the power to breathe fire into it, to make something (the big bang) happen!

Jastrow supposed Albert Einstein shared his thoughts about science pointing to God. He quoted Einstein, "the harmony of

Commissioner's Questions

Short-Term Rentals (STR) – Part 1

My office has received some inquiries about Short-Term-Rentals (STR) in Union County. All counties across north Georgia appear to be seeing an increase in these units, and Union County has its fair share. Though we do not have a complete solution for all the issues associated with STR at this time, we have been study-

ing and researching our options. The next two week's Q & A will discuss this topic through questions that have been posed to my office. Q. What is a Short-Term-

Rental (STR)? A. Every county defines STR



differently. The current Union County

Ordinance went into effect back in 2013, and it refers to a Lodging Accommodation. Article VI Sec. 74-161 of the Union County Ordinance defines Lodging Accommodation as any structure or any portion of a structure including any lodging house, studio, hotel, motel, motor hotel, auto court, inn, public club, lodge, tourist camp, tourist cabin, rental cabin, or private club containing guest rooms and which is occupied, or is intended or designed for occupancy, by guests, whether rent is paid in money, goods, labor or otherwise.

The State of Georgia has recently passed legislation that partially defines a Short-Term Rental (STR) as lodging for less than 30 days. In future Union County ordinances, the terminology will follow the state's terminology.

Q. Do we have any STR or Lodging Accommodations in **Union County?**

A. According to our current licensing data, we have around 210 Lodging Accommodations in Union County. Here's what many people don't know: In 2013, we began requiring these Lodging Accommodations to register with the Union County Commissioner's Office by purchasing a business license in order to operate. This license does several things, but most importantly, it allows the Union County Government to monitor how many rental units are operating. It also allows the Union County Government to collect Hotel/Motel taxes on rental revenue. Why is this important? The taxes help to offset additional infrastructure costs that might be associated with having more visitors in our

Leyland Cypress

Leyland cypress trees are a very common and popular landscaping plant. They are planted by people all over Georgia. However, there are a couple of issues that are commonly seen in Leyland cypress trees. Let's talk about Leyland cypress trees, what some of those issues are, and what steps you can take to reduce **UGA** the chances of your Leyland cypresses Watching and Working getting diseased, because recently I Jacob have gotten a lot of Williams calls from people with questions on their Leyland cypress trees. The biggest issue that people have right now is that their trees are turning yellow and brown on the inside. This is due to the lack of rain that we had earlier in the year. With some of the big rains we've had it's easy to forget that we had a period from beginning of April to end of May with very little rain. The tree's natural response is to start to drop the needles that are closest to the trunk. These needles turn yellow and then brown before falling off. The best thing to do if you see this happening is to make sure that you are watering your trees during a dry spell. With the rain we've had lately, the trees should be able to recover and start to green back up. Leyland cypresses have a shallow root system, which makes them prone to drought stress. Another thing to keep in mind is that these trees have an effective lifespan of 15-20 years. So, if your trees are that age and don't look healthy, they probably aren't going to improve significantly. The two canker diseases that Leyland cypress trees get are Seiridium and Botryosphaeria canker. Seiridium canker is the most common and destructive of the two in Georgia. The symptoms from both diseases look very similar. You will see individual branches begin to die off. Sometimes you'll see resin in spots on the branches because of the cankers. These cankers are essentially suffocating the branch, leading to the branch turning brown. Once a tree has been infected the best treatment is to remove the dead branch and dispose of the branch. Stressed trees are going to be more susceptible to cankers. During times of drought, trees that are already infected will spread the disease much more quickly. Ice damage and spring freezes can create wounds where infection is able to occur. Trees that are near buildings that reflect sunlight will also be more stressed. Unfortunately, with canker diseases there is not a fungicide that can be used to eliminate the pathogen. Passalora needle blight has become more common as well. This is a disease that will cause the needles to drop off of the tree, working it's See Williams, page 5A


— • – **Biden's Inept Cabinet**

county

Q. Is it possible that someone could have a local STR without reporting it to Union County?

A. Yes, at this time it is possible. However, recent Georgia legislation requires all third-party organizations (VRBO, AirBnB, etc.) to collect state and local taxes and to remit those taxes to the appropriate governmental agency. In other words, for any rental property located in Union County that is advertised through VRBO, AirBnB, etc., the third-party agency collects Union County Hotel/Motel taxes and remits that money to the Union County Tax Commissioner's Office.

Q. I have a vacation rental next door to me. I don't think they have applied for a business license. How can you identify some of the STRs that are slipping through the cracks?

A. Union County has recently contracted with a company that is in business to do this exact thing. The company releases data crawlers (Internet searches), which locate and identify rental properties in Union County that are mentioned on the Internet. The company is in the process of building a Union County database based on the data collected. This information will provide

valuable contact information so that we can ensure that local vacation rentals are registered with the Union County Government.

Q. I don't really understand the role that VRBO, AirBnB, Vacasa, and Homeway play in this situation. Can you clarify how it all works?

A. Here's how it works: These companies market homes on their website - letting the public know about their availability. Vacationers want to know about property location, availability, bedrooms, bathrooms, amenities, restrictions, etc. These sites provide vacationers with this type of information so that educated choices can be made about where they might stay. Potential vacationers can also see photos of properties.

Vacation homes can then be reserved through the thirdparty website. Most third-party websites require payment by credit card, so the entire transaction is done online. Vacationer's show up during their scheduled week. That's a simple example of how these companies play a role helping people find available properties and helping owners to rent their properties.

believed but actually false statements made about Habitat. I'm about to set the record straight.

The No. 1 topmost common myth about Habitat is that a large majority of people "believe that we give houses away for free." This is false. The Habitat Homeownership program does not give out free housing. When a home is built for a local community member, they pay an affordable mortgage, with a requirement of sweat equity, which basically means they will help work on their home through the building process. Donations and help through community volunteers can help lower the cost of the home payments for a Habitat homeowner, and volunteers can put their working hours on building the home toward the Habitat homeowner's sweat equity requirements. We are team oriented here at Habitat and encourage the community to help as much as they can through this process.

No. 2 Myth about Habitat is that "Habitat homes are only available to certain groups of people." This statement is false. We get numerous phone calls here at Habitat asking if they are eligible for a home

even though they don't have children. Many people believe that you must have children to qualify, but this couldn't be further from the truth. Habitat for Humanity does not discriminate on family dynamics, marital status, sexual orientation, race, gender, etc. We strictly follow Equal Opportunity Lending and Fair Housing Laws. We strongly encourage anyone in a low-income bracket with a dream to own their own home to apply.

Lastly, the third myth of Habitat is "that we are a government organization." This is also false. Habitat for Humanity is a self-sustaining nonprofit organization. The only government involvement we have here at Habitat includes government funds such as grants, property, and charitable contributions through reaching out on our part to build affordable housing for neighborhoods. We are truly funded by the support of communities, grants and Re-Store sales.

continued from Page 4A way up to the top. I haven't seen this one here yet, but it is present in the rest of Georgia. The cold temperatures that we have in winter will keep it from becoming too destructive here.

Try to keep plants from becoming stressed by laying mulch around their base. This will increase the moisture retained by the soil, and suppress competitive weed growth. During dry, hot summer days, water the trees if the soil has become dry. If trees are extensively damaged by cankers or needle blight, then they will need to be removed. When planting Leyland cypress make sure to dig out an area 3-4 times larger than the diameter of the root ball. This will improve soil drainage, resulting in your trees being less stressed and less susceptible to root rot
