Firefighter Graduation

On June 21st, Union County Fire Department held a Firefighter Graduation Ceremony. The ceremony was a great opportunity for family, friends and fellow firefighters to honor the students and to celebrate their achievement of completing the classes and becoming a firefighter.

The department has not had a graduation ceremony in a few

years due to COVID-19; however, we continued to have firefighter classes when we were able. After the completion of Recruit Class 106 in May of 2023, we decided to have a graduation ceremony and to include the classes that were completed over the last couple of years.



This graduation had firefighters from four Support Firefighter Classes and three Recruit (Georgia Firefighter I) Classes which were completed between the years 2019 and 2023. Some of the firefighters took both types of classes and received a certificate from a support class and recruit class.

The initial training to become a firefighter begins at the support firefighter level. The support class teaches basic fire topics and how to safely operate on the fireground. Support firefighters perform essential functions to support the other firefighters operating on the emergency scene.

The next, more challenging level is the suppression firefighter (Georgia Firefighter I). These classes are considered our Recruit Classes and involve more time and physical training. In these recruit classes, firefighters are taught more firefighting tactics which enables them to actually enter burning buildings, perform rescues and fight fires. The training can be both mentally and physically demanding.

The graduation ceremony acknowledged the difficulty of the training, the sacrifices of the firefighters, and the dedication of each person to achieve their goal to become a firefighter. We are very proud of these men and women who have dedicated their time and effort into becoming a firefighter. We want to congratulate them and welcome them to the fire department family!

We want to thank the instructors for dedicating their time and effort to sharing their knowledge. We want to thank the families and friends who supported the students through the long nights and Sat-

critic Os Guinness writes. "The problem is not wolves at the door but termites in the floor."

America is still an experiment in liberty. It has been a shining city on a hill for those seeking freedom and prosperity. That's why immigrants, whether legal or not, long to reach our shores. But liberty is not guaranteed. "Sustainable freedom depends on the character of the rulers and the ruled alike, and on the vital trust between them," Guinness writes. "The constitution should be supported and sustained by the faith, character and virtue of the entire citizenry.

Loss of virtue erodes American freedoms. TSA checkpoints, increasing taxes and national debt, and cancel culture signal loss of freedom. People with sincerely held religious beliefs lose their jobs when they refuse to cooperate with a lie. People are subjected to critical theory, which values people based on skin color - e.g., Harvard faces a lawsuit for discriminating against white and Asian American student applicants. Politicians hold citizens financially liable for providing public benefits to non-citizens, who are invited to vote for those politicians.

Such loss of freedom is derived from a dangerous and sharp disagreement about the ultimate authority for values and meaning. British philosopher G.K. Chesterton anticipated the risk that America faces: "Men will more and more realize that there is no meaning in democracy if there is no meaning in anything; and that there is no meaning in anything if the universe has not a center of significance and an authority that is the author

Commissioner's Questions

My office has received questions concerning Georgia's outdoor burn notification system that was effective July 1, 2021 and also the burn ban that is currently in effect for 54 Georgia counties. This week's questions will address the basics that could impact Union County residents.

Q. How has the burn notification law changed?

A. GA code section 12-6-90 eliminates the need to notify the Georgia Forestry Commission when a person, firm, corporation, or association intends to burn hand-piled vegetation/yard debris. Important fire prevention precautions for burners, however, were added.



Q. Do I need to do anything special to burn my yard debris?

A. Yes, people burning are required to follow Five Safety Standards. 1. The burn location must be no less than 25 feet from any woodlands, forestland, or field that contains brush, grass, or other flammable material; 2. The burn location must be no less than 50 feet from structures, which includes homes, outbuildings, etc.; 3. The burning must take place between sunrise and sunset; 4. The person responsible must attend burning at all times until fire is completely extinguished; and 5. The person responsible must take reasonable and necessary precautions to prevent fire escape or spread from the original location.

Q. What am I allowed to burn?

A. Only hand-piled leaves or naturally occurring yard debris can be burned. No household garbage or man-made refuse can be burned under this provision. Debris may not be transported from one location to another for burning.

Q. How does weather play into this scenario of burning?

A. Local current and forecasted weather information is readily available through local media sources and regional and statewide weather forecasting agencies. In addition, the Georgia Forestry Commission provides comprehensive fire weather and fire danger information – information that is readily available at: GaTrees.org

Q. Will Unlawful Burn Notices (UBNs) still be issued? Under what circumstances?



the phrase originated, but mom still uses that term from time to time. The term may have come from an incident which occurred when I was very young

My Daddy walked away from a baseball scholarship at Arkansas because he missed my mother. So, he came home and married my mother in 1957. Dad got a job at a textile mill in Hackleburgh, Alabama. He was paid to work part-time and play on the mill's traveling baseball team. I was born a little over a year later in 1958. Daddy didn't make much money, probably not much more than a \$1.00 an hour. The house we lived in was a renter house on my grandfather's farm located about 1/4 mile south of my grandparents.

The house was an old clapboard house built by my grandfather's brother. An old coal-fired potbellied stove was used to heat the house. We did have electricity. The lights of the house were nothing more than screw-in light bulb sockets with hanging down chains used to turn them on and off. The house was not built very tight. The linoleum rug would rise up from the floor when the wind would blow outside. The house had no running water. We had an outhouse and a well where we would retrieve our washing, drinking and cooking water.

During the winter time we all slept together to stay warm. I was only 3-4 months old that cold December night. Mom said she awoke to the sound of me crying. She felt for me in the bed and could not find me. She woke up Dad in a panicked voice and said, "Somebody has taken our baby." They could hear me crying and Dad said, "Your voice sounded as if you were going farther away." So, Dad reached for his shotgun and ran outside looking for the kidnapper. You should remember we were located 7 miles from the nearest town. Our nearest neighbors were my grandparents, and they were a quarter mile away. Why would anyone come to our house to steal me?

While Dad was running around the house, Mom calmed down enough to logically think about the situation and looked between the bed and the wall of the house. There I was, lodged between the bed and the wall. She picked me up and See Cummings, page 5A

of July coming I thought I would talk about how to select a ripe watermelon.

Watermelon requires a lot of heat to be able to grow. That means that watermelon grown in the mountains won't be ripe in time for the 4th of July. There are smaller varieties that don't take as long to grow. Typically, watermelon take 70-90 days to be ready to harvest. If you are planting your own watermelon it's typically easier to start them from transplants, but you can start your own seeds. Watermelon plants will need 8 feet of space on each side.

If you are picking watermelon off the vine you want to look at the curly tendril that is on the stem closest to where it meets the fruit. When you see that curly tendril dry up and turn brown the watermelon is ripe and ready to harvest.

If you are looking at watermelon that has already been picked there are a couple of tricks that you can use so that you look will a pro and WOW onlookers at the grocery store or market. You can thump a watermelon to gauge its ripeness. A ripe watermelon will have more of hollow thud sound to it. An unripe watermelon will have a higher pitched, less hollow sound to it. It's usually best to thump multiple melons with this approach to really be able to gauge the ripeness. Another approach is the check the ground spot. This is just the spot where the watermelon sat on the ground. If it has a creamy yellow or buttery white color then it is ripe. If the ground spot is plain white then it's not ripe yet.

As watermelon ripen the green color will start to dull. So, if the watermelon still has a sharp green hue, it's probably not ripe. If you are picking a striped watermelon this method is particularly useful. Another tip is to pick up two watermelons of similar size. The heavier one is riper. Be careful using this tip because if it is too heavy, then it's overripe.


A whole watermelon will stay ripe for about 2 weeks if its stored below 60 degrees. At run temperature it will last for about 10 days.

Seedless watermelon is very popular and make up 92% of watermelon sales in the US. Seedless watermelon is not genetically modi-See Williams, page 5A

A. Unlawful Burn Notices are issued whenever illegal materials are being burned, including household garbage, man-made materials, personal papers, corrugated boxes and pallets. Rangers at the local county unit who respond to wildfires determine whether an Unlawful Burn Notice must be issued. UBNs may be issued if wildfire results from a yard debris burn AND if it is clear that the fire required safety precautions have not been followed. At the website: GaTrees.org you will find a copy of the legislation, helpful videos, and information about burning safety.

Q. Is Union County one of the 54 counties listed in Georgia's current burn ban?

A. The burn ban went ness and suppression tools.

into effect May 1, 2023 and goes through September 30, 2023. Union County is not listed as a county required to refrain from burning outside debris. Debris burning can still be done in Union County as long as the following rules are followed: Set spacing between fires and woodlands and structures, burn times from sunrise to sunset, burner attendance at the fire, and reasonable precautions such as weather aware-

fied, rather it is how they are bred that makes them seedless. Some watermelon is diploid, which means they have $\overline{2}$ sets of chromosomes. Other watermelons are tetraploid, which means they have 4 sets of their chromosomes. When plant breeders cross pollinate a diploid with a tetraploid it creates a watermelon that produces a seed that are triploid. Those triploid seeds are planted to make seedless watermelon. Triploid watermelons are sterile. It's a similar concept breeding a mule, which is a cross between a horse and a donkey. These seedless watermelons might still produce a few seeds, but they won't mature and turn black.

Ten Things You Did Not Know About the **Knights Templars**



Part 3 of 10: Templar Discipline Was Harsh

Templars knights were legendarily tough soldiers, known for their iron discipline. This was enforced with a system of harsh punishments.

Minor infractions were punished with floggings, while more serious misdemeanors, such as fighting or disobeying orders could result in a brother being forced to eat his meals on the floor with the dogs for up to a year.

Punishments were carefully outlined for even the most minor infractions. Some were relatively mild and almost comical. For example, if any Templar displayed pride in his appearance and sought out nicer, finer garments, he was to 'be given the worst'.

But what if a knight committed a more serious violation of the Latin Rule? If a Templar fought with a fellow knight, lost their horse, was found to be telling lies or succumbed to his baser desires by sleeping with a woman, he could face the loss of habit meaning being stripped of his garments, weapons and status in the order. It was only by appealing for redemption that the brothers could restore his habit after a period of time.

Even more serious violations - such as killing a fellow Christian, committing sodomy or fleeing the battlefield - would lead to a knight being expelled from the Templar order.

However, redemption could still be found even for such men, as they could be ordered to join the Cistercians, an order of monks with close ties to the Templars. It's one of the bitter ironies of history that the Templars, who were so synonymous with their ultra-strict and pious lifestyles, would eventually stand accused of the most extreme heresies and debaucheries.

During the purge and bloody downfall of the order, the knights were said to have indulged in occult worship, spitting on the cross and engaging in homosexual rituals. They were tortured into giving (false) confessions, leading to the Catholic Church (and Pope Clement V) to take down the Fraternity, ultimately arresting the grand master, Jacques de Molay, on charges of heresy, sacrilege and Satanism.

Under torture, Molay and other leading Templars confessed (proven to be false) and were eventually burned at the stake.
