After September 11th, we made a promise. That promise was to Never Forget. But how short are the memories!!!! A famous



Commissioner's Questions

The following questions/answers illustrate your property taxes at work to help make Union County a safer and more affordable environment in which to live.

We feel that Union County has one of the best rural fire departments in Georgia. We have a total of 16 paid firemen working for you with four on shift 24/7 - all day and every night - plus five

additional staff for a total of 21 fulltime paid staff. In addition, we have approximately 65 dedicated volunteer firemen that donate much of their time and effort to assist the public and are constantly taking additional training to improve their skills. Our fire



department makes about 2500 calls per year - all in an effort to make Union County one of the safest counties in which to live.

Q. When was Union County last surveyed for ISO (PPC[™]) fire rating?

A. Union County was surveyed in January of 2021. Union County Fire Department, Union County E911 Communications, City of Blairsville Water Department, Notla Water Authority and Coosa Water Authority were all proud to announce that Union County's PPC[™] class remained at 4/4Y. The PPC[™] ranges from class 10 (worst) to class 1 (best).

Q. How does Union County Fire Department rank in the state?

A. Union County is one of 32 counties in the state of Georgia with a class of 4 and one of five counties north of Atlanta with a 4 class. All departments work continuously to prepare for the survey

Q. What agencies are examined and to what extent by ISO?

The E-911 dispatch center, which makes up 10% of the survey, was evaluated for equipment, personnel, and training. The water departments, which make up 40% of the survey, were evaluated for hydrants, water pipes, supply, and usage. The fire department, which makes up 50% of the survey, was evaluated on apparatus, equipment, training, station placement, response times, and the number of firefighters on scene of structure fires.

Union County is very proud of our Fire Department, both

TSPLOST Tax **Dear Editor**,


In 2012, we had a 1% statewide TSPLOST sales tax that the State of Georgia offered. That tax was a six-year tax where all the monies were to go to Metro Atlanta for the first five years, and Union only got the dollars for the sixth and final year. This year, 2021, our single commissioner is having a Union County-only vote for a 1% sales TSPLOST tax. The dollar amounts of this tax follows: as of Aug. 1, 2021 (apparently the plan is a work in progress), the state projects by the Georgia Department of Transportation listed in the Statewide Transportation Improvement Program section of the master plan for Union County is mainly for the four-lane highway from Blairsville to Young Harris. This is a four-year plan, but a five-year tax.

millage to drop 3.159 mills after revaluation, Tax Commissioner Lee Knight says "they're going to roll back the inflationary increase,' they being Lamar and the School Board. So, I did the math on my property using the advice in the article. Using my new fair market value, \$237,600, multiplied by 0.4, minus my \$2,000 homestead exemption, further multiplied by 0.015759, and came up with a new tax bill of \$1,466. Last year, I paid \$1,050. So, let's do the math on the increase. \$1,466 - \$1,050 = \$416, divided by \$1,050 = 0.396, or a 40% increase. Exactly how is this a "rollback" that collects only what "they" collected last year? Someone is blowing smoke and I'm choking on it.

I would urge all you property owners to do the same math on your property using the new rate, and compare your upcoming tax bill with last year's. When you get the "good news" on your new tax bill, you may want to contact the taxing authorities. I intend to do just that. Again, here's the math: New market value (you should have received the info earlier this year) multiplied by 0.4, less any homestead exemption, multiplied by 0.015759 (as spelled out in the newspaper article). DO IT!

As Gomer Pyle often said, SURPRISE, SURPRISE.

• **Thankful for a Near Miss** Dear Editor,

September 11th this year will be very special for me, the 20th anniversary of the day I almost died in a terrorist attack on the Pentagon. At the time I was working for Northern Virginia Community College. As a military retiree who once served a tour in the Pentagon, I still had a building pass, and the college naturally selected me to operate their extension office there. On 9/11, I planned to arrive early, but as I backed out of our driveway, I noticed an apparent food stain on the front of my shirt. So, I went back inside and changed, a process that took about 10 minutes. That's about how much I missed the plane crashing into the building. While still on the highway about a mile away, I could see a tall, dark column of smoke rising from the site. When I got to the parking lot, hundreds of people were running from the building and police and fire trucks were everywhere. I later learned that 125 persons, some of whom I knew personally, had

The North Georgia News reports, Sole Commissioner Tax-Em has proposed a "TSPLOST" referendum to add an additional 1-cent to the county sales tax (to 8%). Yes, Commissioner Tax-N-Spend argues that "tourists" and "visitors" will pay the tax and it's not really "our money" paying for it. However, he misses the point that the 25,000 residents of the county will pay it all of the time. He is proposing the TSPLOST to potentially reduce the millage rate based on the new county digest value. 




during the late 1940s and early 1950s. They ran with the likes of Tommy Trapp, William Shelnutt, Jerry Cohen and Hubert Brooks. These boys grew up and did everything together. They had a code and it was enforced. None of the boys ever told on another one of the boys. You might not agree with what one of the boys was doing, but, you never told on your buddy.

One day during church the boys were all sitting together, and Paul, my father, noticed that Tommy Trapp had something in his pockets that was causing them to budge. When asked about the contents of his pockets, Tommy pulled out a big nail and whispered, "I am getting even with Old Man Newell." After church the gang of boys walked outside to Old Man Newell's log truck. Tommy walked around the front of the log truck and emptied his pockets of the nails. There must've been 2 pounds of 16 penny nails in front of the wheels of that truck.

Paul and his younger brother Bud felt sorry for Old Man Newell, so, after Tommy and the other boys left, they began trying to kick the nails away from the front of the truck. At this point in time, Old Man Newell came up and thought the boys had placed the nails in front of his wheels. The old man had a fit and screamed out, "You boys are trying to give me a flat tire." Papa ran up to the boys and whipped them in front of the whole crowd. Paul and Bud would not tell on their buddies. So, they took the whipping without a word. But, they vowed to take vengeance on Old Man Newell.

Some years later Old Man Newell's logging truck broke down, and the old man was relegated to driving his little buggy back and forth to town. A plan was soon hatched among the boys. One Saturday in the month of June, the boys, including Paul and Bud Cummings, Tommy Trapp, Jerry Cohen, William Shelnutt, and Hubert Brooks, went out to Old Man Newell's house and waited for him to go to bed. After Newell went to sleep, the boys took apart the old man's buggy and re-assembled it on top of his barn. Paul and Bud didn't make it back home until the wee hours of the morning. about on crape myrtles is ambrosia beetles. We have ambrosia beetles every year, but this year it does seem like there are more of them around. Ambrosia beetles are boring insects that will attack a variety of trees including crape myrtle, dogwood, redbud, maple, cherry, apple, persimmon, rhododendrons, azaleas, and others. They burrow into the heartwood of the tree where they make their galleries. Generally, they attack young plants, but they will attack mature trees, especially if they are under stress. That stress could be from drought, flooding, or mechanical wounding. The adults will introduce a fungus they and their young will feed on inside the tree. The adults are only 2.5 millimeters long, so they are very small. The simplest way to identify ambrosia beetle is that they push out some thin strands of sawdust that look like toothpicks attached to the tree. Because ambrosia beetles are feeding on the fungi they introduce and not the tree, a systemic insecticide will not kill them. You can use an insecticide like permethrin or bifenthrin as a preventative spray on your trees. If you catch the infestation early on mature healthy trees and treat them, they may be able to recover.

You can create a trap to monitor when ambrosia beetles start to show up. Collect a bolt of wood that is 2-4 inches in diameter and about 2 feet long. Drill a half-inch diameter hole into the wood as deep as possible. Fill that hole with Ethyl alcohol that is at least 70% and put a stopper cork in the top of the hole. Isopropyl alcohol does not work. Place the near the wood line where you have crape myrtles. The ambrosia beetles will attack the trap first, and you will see the sawdust toothpicks form on the trap. When you see that occur, start treating your trees.

Powdery mildew is a common disease on crape myrtle. You'll see this growing as a white fuzz on the leaves. It's something that we get every year; it's just a matter of when. This disease may look unsightly, but it will not kill the tree. Leaves that have a lot of powdery mildew on them may start to shrivel up and drop early.

Q. When dealing with our homeowner's fire insurance, what does ISO mean?

A. ISO stands for "In-surance Service Office". This is a for profit organization that provides statistical information on fire risk for insurance companies nationwide. They examine each community or county, usually on a four or five-year cycle. They assign a Public Protection Cycle (PPC[™]) rating that insurers use for underwriting and to calculate premiums for fire insurance. It is based on ISO's Fire Suppression Class Schedule (FSRS).

Q. What does lowering or in this case maintaining of the ISO or PPC rating mean to the homeowner?

A. The lowering of the ISO/ PPC rating could mean lower insurance rates for home and business owners. Although there are many factors that make up the insurance rates, the lowering of the PPC[™] can contribute to the reduction of the overall insurance premium. It is up to the individual insurance companies to determine premiums, and not all are affected the same. If you have a question, contact your insurance company to make sure you are being rated properly. You can call the Union County Fire Department to confirm your ISO rating.

Q. What are the exact numbers we need to know to discuss this issue with our insurance company?

A. If a building or home is located within five road miles of a fire station and has a fire hydrant within 1000 feet, it is considered a class 4 in Union County. If a building or home is located within five road miles of a fire station and there is NO fire hydrant within 1000 feet, it is a class 4Y (formally class 8B). All homes or buildings beyond five road miles of a fire station are classified as class 10.

Q. What are some of the major fire protection factors considered within a county?

A. The major elements that are considered in the FSRS are emergency communications, fire department, and water supply. It also has added a Community Risk Reduction section that recognizes community efforts through the fire department to reduce losses through fire prevention, public fire safety education, and fire investigation.

Q. When will Union County be surveyed again for **ISO ratings?**

A. The last new ISO rating took effect on August 1, 2021. ISO expects to survey Union County's fire suppression efforts every 3-4 years or sooner if there have been any major changes to the dispatch center, fire department or water systems. Cercospera leaf spot creates large dark brown leaf spots on the leaves. This can lead to leaves dropping early. Some cultivars are more susceptible to leaf spot than others are. Susceptible varieties are more likely to lose their leaves early.

Sooty mold is dark brown or black coating on leaves and stems. It can be rubbed off. It is a fungus that grows on honeydews. An aphid feeding on the plants most likely forms the honeydews. Sooty molds only cause superficial damage. The aphids causing the honeydew can be treated with an insecticide, but usually treatment is not necessary.

The reassessment took place and the county tax digest was increased by nearly 32%. The average homeowner saw their valuation increase by over 40%. Mine went up 46%. When the irate citizens raised boisterous objections, he claimed that the "state made him do it" because the assessments had lagged for nearly 20 years. He then blamed the County Tax Assessor for conducting the dirty deed and then removed himself another arm's length by saying the contracted consultant actually did it and he had no control. His 2020 millage rate increased property taxes by nearly 18% over 2019 (see page 5B of the Sept. 1, 2021, edition of the North Georgia News). The increase between 2020 and 2021 will be an additional 10.63% (page 5B). This amounts to over a 29% increase in the county tax digest in two years!!!! The Sole Commish is packing the coffers for more tax-n-spending put on the backs of Union County citizens. Page 5D of the newspaper shows a proposed 10% tax revenue increase by the County School Board. The Sole Commissioner had bragged about how low the Union County taxes were compared to other Georgia counties. Îs it possible that the 20-year hiatus in reassessments is coincident with his 20-year plus or minus tenure as the Sole Commish? Whose fault is it that the assessments have not been done as required by state law? Sounds like his 20-year shell game and free ride to belly up to the public trough may be reaching a day of reckoning. He is at it again, trying to confuse and sell the citizenry of Union County on another set of increases. His lengthy blather in the Sept. 1 edition of the North Georgia News attempts to confuse and bamboozle the Union County taxpayer. The Sole Commissioner, alone, has the sole authority to develop, propose, adopt and implement county budgets (and his own salary too) and the tax requirements to meet them. This sounds like a good deal for Union county. But let us look at the nuts and bolts of this deal, and it looks like Union comes out not as expected by the commissioner. Here's why.

An intergovernmental agreement with Blairsville for a 1% TSPLOST tax kicks off a policy or procedure or a set of rules (one never knows for sure which word to use when the Georgia legislature acts) established by the State. These are the facts: a 1% sales tax as proposed by our commissioner will enable an automatic minimum 30% withholding rule by GDOT (when GDOT says minimum, it usually means more). As you can see from the numbers above, Union's share cost of the four-lane is small. But when you add that min 30% hold back, it becomes a huge amount of money Union county gives up, or more accurately, never receives, as GDOT gets it. And Union County is left begging for some of those local dollars, but there are no traffic problems in Union to even come near the criteria GDOT requires to spend those metro dollars here.

So you may ask, where do those min 30% withholding dollars go? To the metro areas such as Atlanta, Macon, Savanna, Gainesville, etc. Let us look at Fulton County in Atlanta. Fulton County passed a 3/4 of 1% TSPLOST tax. A 3/4% tax does not kickoff the 30% withholding rule. They lose 1/4 of that 1% tax but come out smelling like roses. That's because GDOT gets none of those dollars. GDOT has no choice but to spend billions, yes billions, in Metro Atlanta. Atlanta now ranks as the most congested city in America. So Fulton gets their reduced tax dollars to spend the revenue in Fulton County only.

(no one can predict how much) for Union County with a 1% tax would generate the same amount of dollars as the SPLOST tax, but with a huge difference - Union loses 30% upfront to GDOT with TSPLOST. A good estimate from a 1% tax is approximately \$20 million to \$24 million over five years. So let us calculate. I will use a midrange of \$22 million as an example. 22-30% = \$15.4 million Union will receive with a 1% tax.

The commissioner stated in the North Georgia News an estimated collection of \$35 million over five years would be collected. There is slim to zero chance of Union ever coming that close to \$35 million because of the minimum 30% holdback by GDOT.
