Re: TSPLOST Tax

Dear Editor,

I handle transportation policy issues on behalf of Georgia's county governments and was asked to provide you with some information on Single County TPSLOST.

For background info, in 2010, the Transportation Investment Act provided an opportunity for regions throughout Georgia to impose a 1 percent sales tax for a 10-year timeframe to fund transportation improvements within their region. Three of the 12 regions were successful in passing the tax in 2012. The Georgia Mountains Region, of which Union County is a member of, did not pass the Regional TSPLOST referendum.

To provide another transportation funding option, in 2015 the Georgia General Assembly passed legislation that authorized a Single County Transportation Special Purpose Local Option Sales Tax, or TSPLOST. To date, 33 counties have passed Single County TSPLOST.

The sales tax generated from a Single County TSPLOST remains in that county for transportation projects. The only money that "goes to Atlanta" is a small administrative fee the Department of Revenue collects.

The 30% amount mentioned in the letter to the editor incorrectly states the purpose of that 30% requirement. State law says that a minimum of 30% of revenue generated must be used on projects consistent with the Statewide Strategic Transportation Plan (http://www.dot.ga.gov/IS/

The Statewide Strategic Transportation Plan, or SSTP, is a GDOT policy document and does not include an exhaustive list of projects. Because the SSTP identifies a broad range of supportive strategies and programs, many, if



Before I start this series of questions, I want the public to know that while I do not have a pet because I have no time to have one, I have had many dogs in the past. I love dogs and I appreciate the value they offer to those who own them. While some of the comments of this Q & A may seem counter to this statement, I am trying to deal with an issue that potentially has lots of sides based on information gathered from different sources, including the public. Q & A from Union Q. What is a "service dog?"

A. A "service dog" is an Americans with Disability Act (ADA) fed-

Q. What are the most common disabilities a "service dog" assists an owner with?

A. PTSD, Vision Impairment, Hearing Impairment, Hypoglycemia/Diabetes, and Depression.

Q. Is an "emotional support" dog the same as a "service

A. NO! Actually, there is no difference in an "emotional support" dog and a pet. Neither requires certification and most pets provide some type of emotional support to their owners. While not often an issue, some people place vests on their dogs to allow access for the owner and their pets to areas they should not be allowed access, knowing that they are violating the spirit

Q. Does every dog that has a "service dog" vest mean that it is a real service dog?

A. No it does not, but fortunately most people abide by the ADA regulations. You can usually tell when a person has a real "service dog" from the behavior of the dog. They usually are exceptionally well behaved, stick with their owner and will usually be laying at the feet of their owner when in a restaurant or food service establishment.

Q. Are there any Health Department "rules" that apply

Septic Smart

Maintaining a healthy septic system is very important. Fixing a septic system that is damaged from improper use can be expensive and time consuming. Many homes in the mountains are on a septic system, and sometimes the homeowner may be someone who has never had

a septic system before. Let's talk a bit about septic systems and how to maintain

One in five households in the US are on a septic

system. One third of people in the Southeast are on a septic system. Septic systems provide several benefits. One of these is that a decentralized waste management system reduces the risk of disease transmission. A septic system also has environmental benefits because it removes pollution from surface water and recharges ground water and aquifers. There is also a cost benefit because it reduces the need for communities to build large treatment facilities. A septic system that is properly constructed and maintained is provides excellent wastewater treatment. State and county governments regulate septic sys-

There are a few different types of septic systems but generally, they all have a pipe bringing wastewater from the house to the septic tank. In the tank, solids will float to the bottom, where microbes break them down over time. There will be another pipe that flows to the drainfield. The drainfield handles the effluent that comes off the tank. This effluent goes into the soil, where mi-

One problem that you can have with your septic drainfield is roots clogging the stones and penetrating the pipes in your drainfield. Don't plant trees on your drainfield. Also, avoid parking cars or other heavy machinery on it, as this can damage your pipes. Keep stormwater drains away from your drainfield. Excess water in the drainfield makes it difficult for soil to process all the water that is flowing through it.

Another thing to do is to make sure that you have properly disposed of waste. The only things that should go down the toilet are human waste and toilet paper. Be careful about what you put down your sink. Toxins or bleach will kill the microbes that digest and treat the waste in your septic system. If you have a clogged sink, try to use a snake or boiling water to clean it. Never pour cooking oil or grease down the drain. If you have a garbage disposal try to limit its use. This will reduce the amount of fat and grease that enter your drainfield and clog it up.

Another tip to help your septic system is to use your water efficiently. High efficiency toilets

places that serve/sell food? A. Yes. In the State of Georgia, you CAN NOT have any type of pet, service dog or emotional support dog in any public or permitted venue area where food is being prepared. It is strictly against the law and prohibited. You can call the Union County Health Dept. or any other law enforcement agency to report this abuse, because it could negatively impact the public health.

Remember this is only the food preparation area, not the seating area. It is up to the restaurant whether to allow pets in the dining area, except for "service dogs" that are allowed in all areas except the food preparation area.

Q. I have seen little and big fluffy dogs in Home Depot and other stores including grocery stores and Walmart in the shopping carts. In my mind this is a public health issue. Several of my friends find it alarming that pets are allowed in grocery stores and restaurants that are obviously not "service dogs." What are the regulations?

 A. Most of this has been covered in the above answers. However, in researching for this column, we found it is up to the food service store or grocery store to decide if they will or will not allow pets in their

Q. What can we do if we do not feel the way a store is handling its pet issue is sanitary?

A. It is a personal decision for you as a shopper. The obvious answer is to contact the store operator if you see what you think is abuse. In the case of large corporate types of stores, you would need to contact their corporate offices since the decisions related to pets in the stores usually come from above.

Q. Are their any regulations for non-food stores regarding pet access to their

A. No, it is strictly up to the store owner or operator.

sponsibility, they should be given a disincentive for negligence and social irresponsibility. A \$100-\$200 monthly surcharge on their health insurance policies to cover increased medical costs and a bi-weekly mandatory COVID test should be instituted, the same as with many other major employers.

and showerheads can reduce the amount of stress that you put on your septic system. Select the proper load size on your wash ing machine to avoid overloading your septic system. If you can, spread your clothes washing throughout the week. Doing all of your laundry in one day will put a lot of water through

your septic system at one time. Finally, a professional should inspect the average household septic system at least every three years. Typically, it will need to be pumped every three to five years. The size of your septic system is based on the size of the house and the number of bathrooms. Adding on to your house and using more water than the septic system was designed to process can lead to problems. You can tell if your septic tank is full from the odor, sluggish drains, standing water in the drain field, and sewage backing

Gooch forwarded the letter to the Georgia Department of Transportation, which in turn reached out to ACCG's Bowen, as she is familiar with, gives presentations on, and regularly answers questions about the Single County TSPLOST, which is a county-led effort in partnership with cities. Bowen then wrote the newspaper.

ACCG is a nonpartisan group that represents and lobbies on behalf of county gov-

ernment, Commissioner Lamar Paris is a long-serving member of the Association County Commissioners of Georgia and was president of the association in

Sen. Gooch did not support the Single County TSPLOST that passed in his home county of Lumpkin last year, saying he believed "the sales tax should be a rollback to the millage rate in each county, in my opinion, and not just keep adding more taxes to hard-working Georgians."
