Paris talks new roundabout, campground expansion

Union County Sole Commissioner Lamar Paris covered a lot of ground in his Sept. 21 regular meeting, unveiling plans for a roundabout at the intersection of Glenn Gooch Bypass and Gainesville Highway and an expansion of Poteete Creek Campground.

Paris said construction of a roundabout will introduce much-needed safety and flow improvements at that busy intersection, which currently features a stop sign for motorists turning left and right from the bypass onto Gainesville Highway.

The commissioner

with CHA Consulting to Deep South Farm Road and provide a "concept layout" for Pat Haralson Drive at Union the intersection.

"GDOT has requested that Union County assist with getting this concept layout done and work with (them) on the funding that we hope they will provide back to us to maybe (recover) some of these funds," Paris said.

Added Paris, "This will allow work to get started quicker, because the intersection needs improving desperately. And the sooner it can be done, the sooner it will be a much better safety situation, GDOT will improve this intersection as soon as our plan is completed."

As an aside, he noted that accepted a \$12,500 agreement the plans for the roundabout at April to October season. The

Campground, Paris accepted an agreement with Carter Engineering Consultants, not to exceed \$18,600, for the development of a "campground masterplan" to put in 100 additional sites, build a new boat ramp and potentially create a new beach area.

Property owners to get tax break in city

The Blairsville City Council voted this month to lower the city's property tax rate below the rollback rate that must be calculated each year to offset inflationary increases in property values. Originally, the 2023

millage rate was advertised at the rollback rate of 1.271, which, incidentally, matched the 2022 millage rate, meaning that property valuations inside city limits did not increase appreciably due to inflation in the real estate market.

Still, the proposed rollback was set to produce an additional \$10,042 in property taxes from slight growth in the city property digest over the last year, and Councilman Buddy Moore asked if the council could roll the millage back even more to produce a revenue neutral rate.

Following Moore's suggestion in the Sept. 12 collected by Blairsville City regular meeting, with verbal

agreement by Councilman Tony Dyer, the council unanimously voted to accept a millage rate of 1.17, effectively giving property owners inside city limits a minor tax break

Sheriff's Office continues to Morlock makes hometown make drug arrests, seizures

The Union County Sheriff's Office Narcotics Division concluded several investigations this month, including the previously reported Sept. 11 drug bust that resulted in the confiscation of more than half a dozen types

In the pre-dawn hours of Wednesday, Sept. 13, the Sheriff's Office made two more arrests in a separate drug case, taking into custody the married couple William "Bill" Joseph Lueckert and Teresa Robin Lueckert.

Bill Lueckert, 46, has been charged with trafficking heroin laced with fentanyl, two counts of selling heroin laced with fentanyl, and failure to appear. Teresa Lueckert, 51, has been charged with trafficking and selling heroin laced with

Following a multimonth investigation involving heroin and fentanyl sales in the area, deputies served a search warrant around 2 a.m. that Wednesday at the Lueckerts' Voylestown Road residence in the north end of the county. There, they discovered

heroin that field-tested positive for fentanyl. The estimated quantity was enough to justify trafficking charges, UCSO Maj. Shawn Dyer said.

eyebrows/lips with dyes.

Earlier this month, Paris imposed a moratorium on the establishment of Commercial Firing Range Facilities to give his office time to draft an ordinance regulating such facilities, and he held a first reading of the new ordinance in his Sept. 21 meeting.

The moratorium and ordinance come after safety concerns lodged by residents who believe that such a commercial establishment may be in the works, though the Commissioner's Office has said it is unaware of any Commercial Firing Range Facilities being planned or constructed.

Still, Paris said he wanted to get something in place to allow the county to enforce nuisance prevention and safety measures in the event of such developments, to include both indoor and outdoor commercial range facilities.

Regulations would include stipulations on lot size, the inclusion of vegetative buffers, proximity and positioning relative to other properties, hours of operation, etc. Violation of the ordinance would potentially result in citations, fines and even arrest.

Proposed in the ordinance are restrictions specifically on Commercial Firing Range Facilities that will not impact First Amendment activities by private citizens or the future operation of the county's public target range that is currently being constructed off Georgia

A copy of the draft ordinance can be obtained at the Commissioner's Office, and residents may offer feedback and suggestions on the ordinance any time prior to its adoption. The above ordinance and

revisions to existing ordinances are set to receive one more reading each before being enacted in upcoming meetings. Among other business,

Paris declared a local state of emergency after the Aug. 29 torrential rains that caused significant damage in the county and City of Blairsville, including to roads and culverts, Meeks Park, and the formation of a massive sinkhole at Murphy Highway and SR 515.

While Paris is hopeful that the local emergency declaration might help the county and city recoup some of their cleanup and repair costs from federal and state agencies, he admitted there was "no

guarantee," as the rainstorm only affected Union County. The issuance of Short-

Term Rental Licenses remains Comments, Paris said strong, with Paris accepting 28 additional licenses in his September meeting. To date, 528 properties have been registered as short-term rentals in the county since the launch of the new online licensing system in April.

On behalf of the local Sons and Daughters of the American Revolution groups, Paris proclaimed Sept. 17-23, 2023, as Constitution Week and Day in Union County in recognition of the anniversary and importance of the nation's founding document.

Paris then proclaimed Sept. 11, 2023, as Patriot Day and National Day of Service and Remembrance in honor of the victims and heroes killed in the 9/11 terrorist attacks. He encouraged those gathered to

"Never Forget" what happened that terrible day.

In his Commissioner's construction on Fire Station No. 13 in northern Union County would hopefully be finished in a matter of weeks, and that the new Elections Center next to the Sports Complex is "about 30 to 45 days away" from

expect their city tax bills to be mailed no later than Oct. 20 with a due date of Dec. 20.

As previously reported, the county and school portion of property taxes should start being mailed at the end of this month or the first week in October via the Union County Tax Commissioner's Office.

Like the city, property owners will have through Dec. 20 to get their county/school tax bills paid, either in person at the Tax Commissioner's Office in the Union County Courthouse, via mail postmarked on or before Dec. 20, or online at uniongatax.com.

Among other business in the Sept. 12 meeting, council members discussed the need to survey the parcels behind City Hall that remain in the hands of the Blairsville Downtown Development Authority.

Formerly known as the Haralson Property, these parcels include the parking lot, greenspace and empty lot across from Cook's Restaurant. Per a prior arrangement, the city will be taking these properties over from the DDA, an entity for which the city exercises

fiduciary responsibility.

Union County Elections Board creates Education Committee for public outreach

County Board of Elections voted to establish an Education Committee. This committee is charged with the task of keeping Union County voters up-to-date with the latest information available on all things related to the election process and dates.

In Union County, we have a Board of Registrars and a separate Board of Elections. The former Board is primarily responsible for registering new voters and maintaining the voter registration list. They are currently located in the new courthouse. The latter Board is primarily

If you have been to the Last month, the Union new Sports Complex lately you have noticed a new building under construction on the right side of the complex. That is the new home of both Boards, and we hope to start moving into the building sometime in November. Starting with the Presidential Preference Primary Election on March 12, 2024, this new building will be the location of early advanced voting (2/19/24 - 3/8/24).

If you choose to vote by mail, you can submit your application anytime between December 25, 2023, to March 1, 2024. If you are not registered to vote, you have until Februresponsible for conducting ary 12, 2024, to submit your

There may be up to five elections in 2024. The first is mentioned above on March 12, 2024, followed by the General Primary on May 21, 2024, the General Primary Runoff on June 19, 2024 (if needed), the General Election on November 5, 2024, and the General Runoff on December 3, 2024 (if needed).

This person conducted a random check of all of our physical voting system software to verify that the original software had not been tampered with since the machines were introduced in 2019. We are proud to say that we passed with flying colors. Of course we were not surprised because before every election we conduct Logic and Accuracy testing on every machine. This testing is open to the public and we advertise the dates in this newspaper.

In short, with Logic and Accuracy Testing, each piece of voting equipment is tested to assure each contest is voting properly. We do this by testing every candidate and ballot position on the Ballot Marking Devices (the screen you use to record your choices in the precincts) followed by ensuring all scanners are reading the ballots properly. In short, we know how we vote the machine, can verify the printer has the exact same vote, and can verify that the scanner re-

cords the exact same vote. In the coming days, we

Department of Homeland Security. They will closely examine the physical security of the location where we store our voting equipment. They want to ensure that no one has access to the equipment other than the Board of Elections, who serves under oath. We keep all equipment behind multiple locked doors and under camera at all times. We have new equipment on the way that will further enhance physical safety of the ballot marking devices.

The Board of Elections was created in 2001 by Georgia Legislature HB 798. The legislation requires that two appointments be made from each of the two major parties as determined by votes received in a presidential election. The County Commissioner also has one appointment. Board members serve staggered terms.


