The Winter Storm

The past weather event, with its extremely cold temperatures and small amount of snow, has kept Union County public safety very busy. Winter weather is a common occurrence in our mountain community. However, a winter system with extremely low temperatures is something that we do not experience often.

The winter storm was first presented to Union County

Emergency Management Agency (UCEMA) a few days prior to the drop in temperatures. This is the preparation phase of any event where public safety evaluates the potential situation and begins contacting resources that may be used to respond. The presentation focused on the extremely cold temperatures, the wind speeds, the wind chill fac-

tors, and the extended amount of time that the area would be

below freezing temperatures. UCEMA, fire department, and E911 Communication Center were communicating with community partners and making preparations. Community partners included local and state government, Georgia Emergency Management, utility companies, private organizations, volunteer organizations, and other public

safety agencies on the local and state levels. We were preparing

for an increase in call volume, winter operations, and coordina-

tion of resources to assist the public as needed. Power outages and the Wind Chill Warnings were our greatest concerns The winter storm presented a multitude of issues and emergencies. The fire department responded to six structure fires, six other fires, 21 medical calls, and four water flow/fire alarms from December 22nd to December 26th. The structure fires were significant building fires requiring multiple firefighters and apparatus. There were several homes that caught fire and the others were outbuildings or garages. Most of the alarms were "water flow" alarms on sprinklered buildings. These were, for the most

The utilities were having issues as well. The increase in demand for power throughout the entire Southeast caused TVA to implement power conservation measures. The water companies were experiencing outages and reduced water pressures due

part, burst sprinkler pipes that caused water leaks and the water

flow alarms. The burst pipes caused significant water damage.

Commissioner's Questions

Q. What do I need to do if my green address marker is missing or damaged? A. The green address markers are especially important

for aiding public safety personnel in finding your home quickly and efficiently in cases of emergency. Delivery vehicles also find these markers helpful. If your address marker is damaged or missing, please call the Union

Q & A from Union County 911 Mapping Office at 706-439-6056. They will place it back County in the correct spot, and if it is damaged, they will bring a new one and replace the damaged one. Lamar

Q. Is it true that our green address number signs tell us how far our driveway entrance is along a particular road?

A. Yes, it is. Every numbering of 1000 equals 1 mile. If your address marker is 1000, it means that your address is 1 mile from the street entrance. If your address is 4725 Blue Ridge Highway, it means that you are located 4.725 miles (4 & ¾ miles) from where the Blue Ridge Highway starts. So, if your address is 246, that means that you are located 0.246 miles (1/4 mile) from the street entrance. Another way your address is helpful in that even numbered residences are on the right side of the road and odd numbered residences are on the left side of the road. This makes it easy for public safety and delivery personnel to find your home. Once they arrive at your road or street, they instantly know when to start looking for your address marker and they know on which side of the road you are located. These markers serve as one example of the small things that we do for our citizens and residents that can make life a little more pleasant and safe.

Q. Do all counties use the same 911 addressing system

A. No, we are one of the few rural counties in the State of Georgia to have this. It was something I saw in one of my commissioner classes many years ago as a suggestion. While it is seemingly a small thing that not many people notice, it is something that is particularly important for the safety of the public as well as for vehicles attempting home deliveries. Public safety is always number one for our citizens and this is a large, silent

Wildland-Urban Living

Many people are moving out of urban areas into "natural" areas to take advantage of the natural beauty, recreational opportunities, and more affordable living (it's getting crowded out here in the forest!). Once upon a time that made sense, but now people are moving into these new

mega subdivisions where you had better have a good relationship with your neighbors, because they are only a short stone's throw away.



More than once I have heard "if I want to borrow a cup of sugar, I just open my window and reach across to my neighbor, or if my neighbor's window is open, I

These are extreme examples, but soon, several counties up here will not have any more farmlands left; it will be covered up with these houses that all look alike. I feel sorry for the old folks who farmed their whole lives on their piece of land and now are forced to sell the land for the next development. Developers are building neighborhoods to accommodate this influx. As a result, fire departments are fighting fires along the Wildland-Urban Interface (WUI), defined as areas where homes are built near or among lands prone to wildland fire. The increase in the WUI threat has been steep because of continued development and exposure. The WUI is not a place, per se, but a set of conditions that can exist in nearly every community. It can be a major subdivision, or it can be four homes on an open range. According to the National Fire Protection Association, conditions include (but are not limited to): the amount, type, and distribution of vegetation; the flammability of the structures (homes, businesses, outbuildings, decks, fences) in the area, and their proximity to fire-prone vegetation and to other combustible structures; weather patterns and general climate conditions; topography; hydrology; average lot size; and road construction. The WUI exists in every state in the country, and in our North Georgia counties, everyone lives in the WUI since forests are all around us and the danger from wildfire is just as great here as it is out West where they have the spectacular wildfires that can consume 400 homes in an afternoon. We don't normally have conditions like that here, but if we lose one home to a wildfire, it is a tragedy just the same for the folks who live there and are without a home after the fire.

Wind-blown embers are a major cause of concern in the WUI. Most structures within the WUI are not destroyed from direct flame impingement, but rather from embers. Embers may precede the flaming fire front, carried by the winds that distribute burning brands or embers over long

Radon Awareness

January is National Radon Action Month. Many Georgians spend these cold months huddled inside waiting for a warmer spring. This makes it even more important that we test our homes for radon, a colorless, odorless gas that is the second leading cause of lung cancer.

In Union county, about 46% of homes have elevated levels of the naturally radioactive gas radon. In Towns County, it is 36 %. Over the



course of many years, exposure to this gas can cause lung cancer even in non-smokers. In fact, radon is the leading cause of lung cancer among non-smokers. Smokers, current and former, exposed to radon gas have an even greater risk of developing lung cancer.

Radon is a naturally occurring gas that comes from the breakdown of uranium in soil and rock. Often granite rock naturally has high levels of uranium, which is part of why radon is such a persistent problem in Georgia, the gas seeps out of the soil and up through crawlspaces, foundations, and basements into a home. About 800 Georgians die annually from radon induced lung cancer.

Fortunately, testing for radon gas is simple and inexpensive. You hang a short-term radon test in the lowest living level of your home for three to seven days, and then mail it to the laboratory for analysis. In a few days, you will receive the test results. If the radon level in your home is high (4 picocuries per liter or above), you can have a certified radon mitigation professional install a radon reduction system that will reduce the indoor radon level. The system most frequently used is a vent pipe system and fan that pulls radon from beneath the house and vents it to the outside.

A radon test kit can be obtained from the UGA Radon Program (radon.uga.edu) or many hardware stores. You can also purchase a radon test kit at the Union or Towns county Extension office for \$15. Testing for radon is very easy and effective, and I recommend it to anyone that has purchased a home or is living in a home that has not been tested.

Radon may also be found in drinking water. This is primarily a concern with private well water. In Georgia, wells drilled into granitic crystalline rock aquifers, usually in the northern part of the state, are at risk of naturally occurring radon contamination. This is where the uranium that decays to radon can be found at higher levels. To learn more about radon in water in your county visit https://aesl.ces.uga. edu/water/map/. Q. Who do I notify if my road sign is missing?

A. Road signs are just as important as the green address markers for public safety personnel. If your road sign is missing, immediately report it to the Union County 911 Mapping Office at 706-439-6056. Once it is reported, a new sign will be made and installed. However, when there is no sign, 911 Dispatch can notify emergency personnel of the missing road sign in the event of an emergency on your road. We seem to have a continual problem with the theft of street signs. If you ever see anyone tampering with a street sign or of you locate a street sign in a ditch or on the side of the road, please contact 911 with location information.

2016 were caused by ember showers from the mountains above that rained down on the unprepared city and surrounding areas. These ember showers were caused by the extreme winds and dry conditions that created the perfect storm that consumed a large portion of the city that destroyed more than 2,200 homes and businesses and killed 14 people. I talked to a firefighter from South Dakota who was deployed to Gatlinburg during the fires, and she said that all the homes in the neighborhood they were assigned to protect were threatened by fire and they had to choose to try to save only those that were savable and safe for the crew. The savable ones were the homes where the owners had taken preventative measures to remove fuel on and around the structures or were built with non-combustible materials. The most important thing we learned in Firefighter 101 is that safety for the firefighters comes first, and in Gatlinburg, the crews could not put themselves in jeopardy to try to save a home that was a hazard to them or their equipment. Fire engines cost much more than most houses, and firefighters
