

# Panthers secure No. 1 seed in 8-AA, host Region tourney

Roswell - Union County (20-5) will host the 8-AA boys? tournament as the region's top seed for the second straight year following an 87-39 blowout victory at Fellowship Christian on Tuesday, Feb. 6.

Last week's rout puts a bow on a regular season that saw the Panthers reach 20 wins for the first time since 2006-07 -- head coach Corey Garrett's senior season at UCHS. Additionally, Union County has clinched a Class AA State Tournament berth for the sixth consecutive year.

The Panthers will open region tournament play vs. 5th-seeded East Jackson on Wednesday, Feb. 14. The Eagles (11-13) stunned 4thseeded Banks County (14-12) in Saturday's play-in game, denying the Leopards a 10thconsecutive state tournament. Meanwhile, East Jackson advances to state for the first time since 2018.

This week, the Panthers will attempt to terminate a 43-year region title drought that includes five consecutive region championship game losses (1982, 2000, 2001, 2022,

points by Maddox Young and a transition-3 from Ellis before Combs and Young put the finishing touches on the Panthers' 62-20 half.

Union County outscored Fellowship 14-11 in the third and 11-8 in the fourth during a mercy-rule-shortened, 12-minute second half.

Combs finished with 8 points and 7 rebounds; Young had 6 points, 5 rebounds, 3 assists and 3 steals; Dockrey went for 5 points, 3 rebounds, 2 assists and 2 steals.

Sophomore Kainen Shirley had 5 points and a steal; Totherow added 6 points and 2 rebounds; sophomore Vince Marevka had 3 points, a rebound and a steal; freshman Hayden Price finished with 2 points and a steal; sophomore Holden Payne had 1 point, 1 rebound, 1 assist and a steal.

Freshman Ethan Hogsed chipped in an assist and a steal.

Game stats: Union County scorched the nets to the tune of 56% shooting (29-52), 71% (20-28) at the line and 47% (9-19) from downtown. Fellowship made 35% (16-46) overall, 43% (6-14) at the stripe and 10% (1-10) behind the arc.

Union out-rebounded Fellowship 34-25, outscored them 38-28 in the paint and won the turnover margin 24-9.

Now, the Panthers' attention turns to East Jackson where a win sends Union into its third consecutive region title game.

"Just because [East Jackson] upset Banks, by no means does it mean we have the night off," Garrett said. "[East Jackson] beat us at their place so we know it's going to be a tough game."

### Lady Panthers reach 15 wins, enter Region tourney as No. 2 seed

Roswell - The Lady Panthers (15-10) increased their yearly win total for the fourth straight year by surviving another road upset bid at Fellowship Christian on Tuesday, Feb. 6.

Unfortunately, Union County learned that senior four-year starter Lara Turner is likely done for the year due to an injury that cost her the better part of the last three games.

"It's just a tough situation for a great kid," Union County head coach Thomas Nelson said. "She's played such a vital role in our success and we've had to adjust to not having her in the lineup. "But on the same token, with the 2-seed locked up, we've been able to get some other girls in and give them the opportunity to play these last few games. So it's something we've been able to plan for." With the No. 2 seed in the upcoming Region 8-AA Tournament, the Lady Panthers have earned a state playoff berth for the fifth consecutive season. Union County opens the postseason vs. 3rd-seeded Athens Academy at 6 p.m. Tuesday, Feb. 13 at Banks County. With a win over the Spartans, the Lady Panthers would advance to their first region title game since 2020, where the winner of top-seeded Banks County and 4th-seeded Providence awaits Friday night in Homer. The 8-AA consolation game is at 6 p.m. Friday. Lady Panthers 60, Fellowship Christian 48 - Union County pulled away from the Paladins following a slow start in Roswell behind 28 combined



to 17 near the 2:15 mark on Mull's fast-break layup, Mc-Carter's coast-to-coast bucket and Brown's putback.

McCarter added three free throws on the next two possessions to push the gap to 48-30, then a Hensley Adams free throw and a 15-footer by freshman Nomi Nelson sent their squad into the fourth up 17.

The Paladins narrowed the deficit to 51-39, but Brown immediately fed a cutting Robertson under the basket for a 3-point play. However, a Fellowship trey moved the home team within 56-46 at the 3:37 mark, and then a Paladins floater had the margin at 8 points inside of 2 minutes.

slow," Nelson said. "Those teams that we blew out early in the year have all improved and I think it takes us some time to adjust.

The Lady Panthers fell into an early 14-7 hole but used an 8-0 run ahead of an 18-16 advantage after a quarter.

Junior Hope Taylor ignited the rally with a putback at the 2:50 mark of the first.

"Hope has come a long way from a player that didn't get to play much last year," Nelson said.

Then, after a Fellowship miss, senior Kamryn Mull started a 3-on-1 break when she fired upcourt to Robertson, who hit a streaking McCarter in stride for a layup.

Junior Katelyn Brown swatted away a pass on the defensive end, resulting in Robertson's step-back jumper on the other end. Robertson put Union on top 15-14 on the ensuing possession with a baseline drive at the 1:17 mark.

Fellowship stopped the run, scoring out of a timeout, but the lead was short-lived as junior Hensley Adams connected from 20 feet for an 18-16 score. Fellowship pushed ahead

22-18 early in the second, but McCarter converted a steal into two free throws. Moments later, Robertson sank a pair at the stripe to even the score.

Tied at 22-22 with under 3:30 to play in the period, Union County outscored the Paladins 11-1, closing the half up 33-23. The 10-point swing started with a Mull 3-pointer and an offensive board by Taylor for a 27-22 lead. Brown earned a trip to the line on each of Union's next two possessions, sinking 3 of 4 for a 30-22 lead at the 1:53 mark.

"Brown does everything we ask her to do and is the glue that holds the team together," Nelson said

Later, Brown's offensive board allowed Mull to find Robertson for a trey and a 33-22 advantage before a Fellowship free throw reduced the halftime difference to 10.

The Lady Panthers grew their lead to 45-28 during the third and maintained a 51-34 edge entering the fourth.

Sophomore Mady Adams kicked off the second-half scoring with a short jumper, but Fellowship moved within nine at 45-36 with 4:40 left in the third.

Three free throws by Taylor and one from Robertson increased the Union advantage to 39-28. The lead grew

McCarter knocked down two free throws with 1:21 to play, and Mull's strip on the defensive end sealed the victory.

Robertson scored a teamhigh 15 points with 8 rebounds, 4 assists and a steal. McCarter had 13 points, 8 rebounds, 2 assists and 4 steals.

Taylor finished with 11 points, 10 boards and 2 steals; Mull had 8 points, 3 rebounds, 2 assists and 2 steals; Brown scored 5 points with 5 rebounds, 2 steals and an assist.

Hensley Adams had 4 points, a rebound and an assist; Mady Adams added 2 points and 2 rebounds; Nelson chipped in 2 points and 2 boards. juniors Aubrie Akins and Sloane Dyer pulled down 3 rebounds apiece; freshman Izzy Anthros and Ragan McCarter both collected 2 boards; freshman Regan Trlica had 2 steals.

'I'm really proud of the kids' effort and the support we've gotten from the fans and the community," Thomas Nelson added.

## Wrestling: Union sends seven to State Championships


Rockmart - Union County qualified seven of its 13 wrestlers at Sectionals for this weekend's Class AA State Championships, headlined by Paxon Legatt and Payton Legatt, who both took home first place and earned a No. 1 seed at State.

Senior Anderson Clouse (138 lbs) and junior Asa Smith-Foot (175) each placed second. Senior David Heredia (190) and freshman Eli Flowers (106) came in third; junior Beau Webster (285) placed fourth at the Saturday, Feb. 10 Sectionals tournament.

At 144 lbs, freshman Paxon Legatt won the sectional tournament by earning a convincing 8-1 decision over Banks County's Evan Mullins, whom Paxon Legatt defeated in the Area 8 finals.

During the semifinals, Paxon Legatt pinned Cook's Maliq Vickers after a narrow 4-2 decision over Murray County's Caleb Blair in the quarters. His day started with a 24-second pinfall over Jeff Davis' Chaz Wood.

Paxon Legatt's older brother, junior Payton Legatt, took down Cook's Jed Roundtree in the finals via a third-round pinfall at 157 lbs.





### Soccer: No. 3 Panthers overwhelm No. 10 Lumpkin Co.

Coming off a final-four berth in 2023, Class AA's thirdranked Union County returned to the pitch last week by going 1-1 at home against two of Class AAA's top programs.

On Tuesday, the Panthers opened the season by dropping a controversial 3-2 decision to the defending Class AAA State Champion and No. 1 ranked Coahulla Creek (Dalton). Later in the week, Union jumped out to an early 3-0 lead during a 4-1 victory over No. 10 Lumpkin County.

The shorthanded Lady Panthers, still missing several key players due to basketball, dropped a pair of 10-0 contests to No. 10 Coahulla Creek and No. 4 Lumpkin County.

No. 3 Panthers 4, No. 10 Lumpkin County 1 - Junior Antonio Solario notched a hat trick in Union's decisive victory over Lumpkin at Mike Colwell Memorial Stadium on Friday, Feb. 9.

The Panthers struck early minute. courtesy of its two senior preseason All-State selections: Evan Bohms and Zuriel Mancillas. The duo hooked up 32 seconds into the contest when Bohms fielded a long-range through pass from Mancillas and beat the sliding keeper, netting Union's first goal. Solario got in on the scoring during the 6th minute, finishing off Mancillas' corner kick with a header into the back-right corner
