

Letter Drive

It's that time again. Time that you may receive a letter from your local volunteer fire department. Every year, the volunteer fire stations send out a letter to the citizens and business owners who are protected by their stations. The letter serves several purposes. It informs the people on the operations of the stations. The letter provides information including the number of members; the number

of calls; any changes to the stations; any equipment purchases; and any needs that the station may have. They also provide information on the future goals of the station to better respond to emergencies and serve the community.

The letter also provides dates and times for each fire station's an-

nual open house. This is an invitation for the people to visit the fire station. The volunteer firefighters display the station, the apparatus and the equipment. They are available to answer questions. Often there are educational displays and demonstrations of fire and rescue equipment.

The main purpose of the letter is to ask for donations. Although the fire department's budget pays for utilities and maintenance, most of the volunteers' purchases and operations are made possible through donations. The annual letter drive is the main source of donations for the volunteer stations. The volunteer stations survive on the generous donations provided by the citizens and business owners of their coverage area. They use the donations to purchase radios, turnout gear, wildland gear, and various other firefighting and rescue equipment. They also use the funds to purchase fire apparatus, rescue trucks, and to make improvements to the stations.

Every donation is needed to keep the volunteer stations operational; to achieve future goals; and to respond to emergencies throughout the county. The volunteers do not ask for a dollar amount. They ask citizens and business owners to donate what they can to assist the stations in serving their community. The continued support from the citizens, business owners and the community is greatly appreciated by the dedicated volunteers and the department.

So, when you receive a letter from your volunteer fire station, we ask that you read it to stay informed. We also ask you to come to the open house of the fire stations. But most important, we ask

The disciples' encounter with immortality so dramatically changed them that they risked imprisonment for "proclaiming in Jesus the resurrection from the dead" (Acts 4:2). They were not deceived. They had no reason to lie. They knew the Truth. They were motivated by love for their fellow man.

Jesus' Resurrection matters because "if Christ has not been raised, your faith is worthless" (1 Cor. 15:17). Those who dismiss this historic event as myth or metaphor are entitled to free thought, but such a view is not what the Bible portrays, nor would it have inspired those early believers. When Jesus arose from the dead, he fulfilled prophecy, validated his identity as God the Son, and claimed victory over sin and death. 

Commissioner's Questions

Our office has received numerous calls from residents asking about the possibility of installing speed bumps on certain county roads because of speeding vehicles. There are advantages and disadvantages of installing these types of obstacles on our roads, so I wanted to share some of the questions and answers related to that.

Q. Why do people speed through neighborhoods? Don't they realize kids are playing outside and adults are working in their yards? A. We all seem to be in a hurry

to get to our destination. Sometimes



we forget that our neighborhoods are DELICATE communities where neighbors visit, children play, residents walk their dogs and pets often roam. Sometimes people are actually "cutting through" one area to get to another. People speed for different reasons, and nothing can ever be good about speeding in a neighborhood or on any road approaching a neighborhood area.

Q. Why isn't the Commissioner's Office doing anything about the speeding in our neighborhoods?

A. Traffic and vehicle control in Union County falls under the authority of the local Sheriff's Office. When vehicles travel at unauthorized rates of speed, very serious safety issues are created. Any resident who has concerns about speeding in a neighborhood can call the Sheriff's Office for advice or for assistance. However, be aware that this is also often frustrating for the Sheriff's Office as it is sometimes difficult to catch someone speeding in a residential neighborhood.

Q. Several households in my neighborhood have discussed the problems we are experiencing with speeding vehicles. Can you install speed bumps along the straight runs of road to slow down the traffic?

A. When it comes to slowing down traffic the first thought that usually comes to mind is the idea of using road obstacles as a solution. People have suggested speed bumps and parking on the side of the street as possible deterrents for speeding vehicles. Of all the ideas we have heard, these two ideas are our least favorite. When speed bumps are installed, it also can impact the safety

Hounds were sitting at the foot of the 500-yearold Spruce Pine. Her litter mate was tree barking at the top of his lungs, and the barking made his master's son proud. Papa and his two sons had raised the pair of young hounds from pups and they were a source of pride to the Cummings family

The young boy was proud of Sam, but, he was also concerned about Lou. She had given a locate bark letting them know the old raccoon had climbed a tree. But, unlike her brother, she had not settled on the tree and had grown quiet. The puzzled youngster, Paul, asked his father, "Papa, why has Lou gone quiet? I believe some-thing is wrong with her." His Papa assured the boy his dog was OK. The middle-aged man smiled as he said, "Lou is learning from that old coon. Do you remember last spring when we thought that old bandit was treed?" Indeed, the boy remembered.

The dogs had run the old coon for more than an hour and at last they treed him up this same giant tree on the edge of Turkey Creek. But, when the boys and their Papa arrived at the tree the coon was nowhere to be found. Papa told them the old coon had taught their dogs a lesson and now for the second time this year Lou was trying to unravel the mystery of this disappearing raccoon. The dogs were well bred and intelligent. Sam was aggressive and gritty while Lou seemed more intelligent and persistent. When she found a track she never left it until the raccoon was treed. So, when she fell silent Papa and his sons listened to see what would happen.

She left her litter mate at the tree and began to circle the tree to see if the coon had tapped the tree. Sometimes when treed by baying dogs a raccoon will go up a tree and then out on a limb. At the end of the limb the coon will jump from the tree and hightail it out of the country hoping to leave the dogs far behind. She circled out to the East toward the creek and found no scent. She then came back toward the West, but, could not travel more than 10 feet from the base of the tree due to the rock face of the bluff. ceive full sun for at

least half a day. They can grow in shady spots, but the fruit production will be less. Blueberries like soil with a pH of 4.5 - 5.2. This trait makes them well adapted to native soils because most of our soils will naturally be in that range. Therefore, lime is probably not needed when planting blueberries. Rabbiteyes do best with 5 - 6 feet between plants in row and 11 - 12 feet between rows. When planting make sure you don't plant too deep. After planting prune back 1/3 to 1/2 of the plant. This will cause the plant to focus on developing its root system. The first year you want to pick off any blooms, because you want the plant to put its energy into growing roots and not fruit. You can apply 1 oz. of 10-10-10 after the plant has begun to put on leaves the first year. The second year after planting put out 2 oz. of 10-10-10 in March and July. Make sure not to over fertilize blueberries, as that can harm them. After the third season, apply 1 oz. of 10-10-10 per foot of height on the bush.

Blueberry bushes do require pruning each year. Once plants reach 6 feet high you'll want to start cane renewal pruning. This means removing 1 - 3 of the biggest canes each winter at ground level. Over a period of 5 years the bush will be completely renewed. New canes are going to bear more fruit than old canes so it's important to maintain this pruning process. If you have bushes that haven't been pruned for a few years, it might take several seasons to get bushes into the 5-year rotation. After you've picked the fruit, you can top plants if they are over 6 feet tall. This will keep bushes at a more manageable height

Blueberries aren't bothered by many insects or diseases. However, one disease to look out for is mummy berry. It will cause berries to shrivel up and drop. The berries that drop carry the pathogen over to the next year. Therefore, it's important to keep the space beneath your bushes sanitary. Remove any old berries, wood, and leaves. Placing thick mulch around the base of plants will help prevent the disease from spreading as well. Captan is an effective fungicide at controlling mummy berry, but the timing of the See Williams, page 5A

of our roadways for salt trucks and snow clearing. Blocking a roadway is never a good idea, and parking on the side of the street might make it impossible for an emergency vehicle to make its way through. Only in very extreme circumstances will the county consider a speed bump.

Q. What are the advantages of using speed bumps?

A. By forcing drivers to slow down, speed bumps greatly reduce the frequency of minor fender benders and serious collisions. More importantly, they are quite effective at reducing automobile accidents involving pedestrians. However, on higher speed roadways, they are sometimes simply NOT safe.

Q. What are the disadvantages of speed bumps?

A. One of the few major drawbacks of speed bumps of any kind is that they are a pain for the traveling public. They are a terrible inconvenience for traveling, school buses, ambulances, and other emergency vehicles. In life-or-death situations, a delay in reaching a person in distress or delivering that person to a hospital can be serious. Also, once speed bumps are installed, salting, and scraping of ice and snow is not always possible because of the danger to equipment, vehicles and employees.

Q. Do speed bumps change driver behavior?

A. Often it is the only way to impact a driver's behavior. However, some will try to avoid the bumps by going "off road" to avoid the bumps or spinning their tires upon leaving a speed bump. Neither is advisable or legal.

Q. Why can't the county just install "Slow Children at Play" signs?

A. Because the streets are not for kids to play on. Any indication such as one of these signs - that kids are allowed to play on the streets and that the activity is known and allowed by the governing authority - is simply not appropriate.

Q. I live in a subdivision where children regularly play outside. Does the Homeowners Association have any authority on this matter?

A. It you live on a private road, one fantastic way to reduce speeding in the neighborhood includes speaking with your Homeowners Association (HOA) if you have one, or at neighborhood gatherings. Your HOA council members or homeowners may know how to slow down traffic in your neighborhood through the use of campaigns, traffic calming solutions, and by working closely with local law enforcement. The HOA will absolutely have the right to step in and install traffic calming solutions, such as speed bumps and speed humps, which help discourage speeding. They might even install a speed monitoring digital sign. But they can do nothing until alerted about the situation. If no one speaks up, then nothing gets done. If you go to an HOA board with multiple

chances of something being done are much higher. Q. If speed bumps aren't the answer, what do you suggest?

A. It is the last resort for slowing down traffic in Union County. However, if nothing else works, it is still sometimes necessary.

Q. What is Union County policy on speed bumps?

A. If there is enough speeding on a particular roadway and if it is persistent for an extended period of time, then you can speak with the Sheriff's Office and/or the Road Dept. If warranted, The Road Dept will paint a warning bar on the roadway and place signage nearby, letting the public know that if traffic does not slow down, a speed bump will be installed. The county will then after (a period of time) install a speed radar type instrument that will record the actual speeds along a section of the road. Finally, if the speed limits are well above the legal limit, then the speed bump signage will be converted to an actual speed bump. So, if you do not want a speed bump, then slow down along rural roads and treat it as if you had your dogs or the public walking along the roadway. Abide by how you would want the public to drive by you in similar situations.
