Community competes to raise money during Super Chef Showdown

Within the first hour of the Super Chef Showdown on Saturday, March 9, more than 100 guests had joined the Hope House of Union County in celebrating the eighth annual event at the First United Methodist Church.

Event organizers invited local churches and organizations to prepare dishes for guests to taste, then vote on for which they believed to be best.

'This is our big fundraiser of the year," said Hope House Board Chair Eric Wood. "We are nonprofit and faith-based, and we help people that are in legitimate need, whether it be a power bill or propane, or whatever they may need.

"They can come to us, and we are open twice a week, and they fill out an application to see if they are eligible for

The organization is also supported by local businesses, churches and individuals throughout the community, as well as the Showdown event, all in the name of helping those in the community who are in need.

"We have community leaders who have agreed to participate as a chef," said Evelyn Ueltzen, treasurer for the organization. "They have all prepared a dish, and they are serving up samples, so the community comes in and pays one admission fee and goes around to taste all the chefs." Each group has a jug that guests use to vote with their money on the agency or dish that they like.

"We have two types of judging," said Ueltzen. "We have jug winners, who win

Members of the Union County Gun Club gathered for their Annual Meeting on Thursday, March 7, inside the Haralson Memorial Civic Center.

Disturbing pattern of behavior precedes double murder in Morganton

MORGANTON - A 35year-old McCaysville man has been charged with the March 4 murder of Amber Jackson, 31, whose 3-year-old son was also found shot to death at the scene, according to the Georgia Bureau of Investigation.

The GBI responded that evening to a call for assistance made by the Fannin County Sheriff's Office concerning a double murder involving Jackson and her young son Ethan, according to the GBI.

Fannin County Sheriff's Deputies made the tragic discovery after responding to a 911 call of "shots fired" at Jackson's address on Underwood Road in Morganton, according to the GBI.

Upon arrival, deputies found the mother and son on the front steps of the apartment, dead from apparent gunshot wounds, according to the GBI

Joshua Lee Fults, identified as Jackson's boyfriend by the GBI, "was located on the porch of the residence suffering from an apparent self-inflicted

gunshot wound."

custody, and he was transported to a medical facility, where he was last reported to be in critical condition, according to the GBI.

"At this time, an arrest warrant charging Fults with the murder of Amber Jackson has been taken by the Fannin County Sheriff's Office," according to the GBI. "Additional charges are expected."

Once the investigation is complete, the case will be submitted to the Appalachian

prosecution, according to the GBI Disturbingly, this was not the first time law enforcement had gotten out with Fults concerning attempted suicide

and his girlfriend, Jackson, according to multiple reports obtained from the Fannin County Sheriff's Office.

Jackson called the law on Fults on June 30, 2018, in reference to a domestic situation at her then-residence on Kingtown Street in Blue Ridge, according to an Incident Report

Fannin County deputies Deputies took Fults into and the McCaysville Police Department responded to Jackson's residence that day, where they discovered a man, Fults, sitting on the porch with a knife held to his wrist, as Jackson holed up inside with her son for safety.

"The male was demanding to speak with his girlfriend, Amber Jackson, or he was going to kill himself," according to a report filed by Sgt. John Bramlett of the Fannin County Sheriff's Office.

City Hall hopes to finish new Blairsville Police Department by midsummer

Renovation of the vacant building next to Blairsville City Hall to serve as the brand new Blairsville Police Department is moving right along, with city officials hopeful that the building could be open by midsummer.

Members of the Blairsville City Council unanimously approved a series of contracts to complete the building in their March 5 regular meeting with Mayor Jim Conley.

Construction will be carried out by Bridges Home Builders to the tune of \$45,869, while other subcontracted costs to include electrical, plumbing, HVAC, etc., will come out to \$62,200, with the overall
