extremely sorry for those individuals and businesses that this caused a problem for.

#### Q. Would this water have been dangerous to drink?

A. Apparently not, but EPD has their requirements and if for some reason the water quality had been compromised, they wanted the public to be protected.

#### Q. How does the City of Blairsville usually publicize a boil water advisory?

A. In the event there is a water line break and a boil water advisory needs to be issued, the City of Blairsville contacts local media outlets. These include the local television station, all local and surrounding radio stations, and now will utilize Facebook. If it is in a neighborhood, they sometimes have to go house to house. They will also be utilizing the Union County 911 Alert System in the future to reach even more people faster.

Q. Why was there a boil water advisory in effect last week?

A. Georgia Environmental Protection Division (EPD) requires that the City of Blairsville and other water systems, if they utilize storage tanks, clean them every few years based on biannual tank inspections. That is what recently happened with the City of Blairsville. EPD requires that if the tanks are cleaned internally by a human diver, a temporary boil band goes into effect. Sufficient planning did not occur and the main problem seemed to stem from allowing the cleaning company to set their own schedule instead of demanding they use the city schedule.

Q. Are there problems with City of Blairsville Water very often?

A. I doubt if there is a more reliable source for public drinking water. We have to remember that they have and do provide reliable water service to their customers 24/7, 365 days per year. This is also the case for Notla and Coosa Water authorities.

Also remember that a waterline does not tell time or know the day of the week and employees are called out all times of the day and night, weekends and holidays, to fix water breaks and insure reliable service, even though we may never know about it.

Although Union County government has plenty to take care of, I will admit to being very glad that we do not have to deal with water or sewer issues and are proud that others are willing to do it for the public.

your poinsettia will be! Getting a poinsettia to reflower is no easy task. These plants have strict light requirements for them to form the yellow flowers and colored bracts.

In the first week of October, the plant needs complete darkness for 14 hours every night. You can move the plant into an area of the house that gets no light, or putting a box over it. The plant also needs about six or seven hours of bright sunlight each day.

Though this seems demanding, after eight to 10 weeks, you should see colored bracts start to grow and the plant will fully come into bloom once again in November and December.

teens aren't hearing enough of the messaging from their parents about the perils of any type of impaired driving. This study presents a good opportunity to start sending out a broader message. Driving under the influence is driving under the substance.

Another study done in 2016 by the Insurance Institute for Highway Safety showed a similar disparity in attitudes toward marijuana and alcohol. It found that, nationally, driving after using marijuana wasn't perceived as negatively as driving after consuming alcohol, which most respondents viewed as a problem in their communities. Less than half of drivers surveyed considered marijuana's effects on driving to be about the same as alcohol.

A University of Texas study published earlier this year, found an increase in fatal crashes in Colorado and Washington after the legalization of recreational use. Safety organizations have begun to study marijuana and its effects on crashes, as more states have legalized its recreational use and as traffic deaths have started to rise.

The federal government, for example, just announced that traffic deaths in 2016 increased 5.6 percent over 2015. This means 37,461 people died on our roadways in 2016, which is 1,976 more than died in 2015. Deaths also rose in 2015 from 2014 numbers.

The Governor's Highway Safety Association published a comprehensive report about drug use on our nation's roadways. The author, Dr. Jim Hedlund, reported that marijuana was the drug that showed up the most of any drug in the system of drivers who died in crashes. No other specific drug shows up in amounts greater than 10 percent. Marijuana, however, accounted for more than one-third (35.6 percent) of the drugs found in testing in fatal crashes.

Another study done by

Safety linked legalizing recreational marijuana to an increase in motor vehicle crashes. The study found that insurance claim rates under collision coverage went up about 3 percent overall after recreational marijuana sales started in Colorado, Oregon and Washington.

At that time an I.I.H.S. statement noted that worry about legalizing marijuana increasing crash rates isn't misplaced and that the findings should give other states considering legalization a reason for pause.

There is good news and bad news for parents in this current study. The study found that where marijuana has been legalized recreationally, a conversation between parents and teens about driving under the influence of marijuana is having an impact on a teen's views of risk.

Where this conversation has taken place between parents and teens, 80 percent of teens think smoking marijuana makes someone a worse driver; where it hasn't taken place, only 72 percent of teens think so. And where parents have had this conversation, 75 percent of teens think this practice is dangerous; where it hasn't taken place, only 71 percent of teens think it's dangerous.

However, if parents need more proof that their teens may not be listening, there is this finding: while the majority of parents (78 percent) say they are talking to teens about the dangers of smoking marijuana and driving, only 53 percent of teens recall having these conversations with their parents.

Since talking about these risks does seem to make a difference, reinforcing the message by formalizing the discussion and putting it in writing can help.

Setting clear rules and expectations is important. These are young adults and they need to know the rules and consequences if they don't play by them. The rule is - there is absolutely no driving under the influence of alcohol or drugs. and the scorned will have their joyful reward in heaven (Luke 6:20-23).

Today the personal and loving Gift is still offered, and received by faith. "God so loved the world, that He gave His only begotten Son, that whoever believes in Him shall not perish, but have eternal life" (John 3:16). Wise men and women still seek and find that delightful Gift.
