ple roadways affected. GDOT work crews treated isolated icing on numerous state routes that included 5/515 and 60 in Fannin County, state routes 2 and 282 in Gilmer County, and state routes 136 and 515 in Pickens County.

Road problems arose because of early morning showers before temperatures began a rapid decline. The aftermath of the showers was black ice almost everywhere as road crews did their best to combat the problem.

Sleet was first reported in Union County shortly before 2 a.m. Monday, Spear said.

By 4:48 a.m. on Monday, temperatures had dipped to 29 degrees with the wind chill factor bringing a feel of 18 degrees, according to the National Weather Service.

By 5:20 a.m., the temperature had fallen to 25 degrees, with the wind chill factor making it feel like it was 16 degrees.

Temperatures continued to drop as the clock ticked. By lunchtime on Monday, it was 18 degrees with a real feel of 4 degrees.

Every snow and ice event is different and a lot of decisions have to be made each time as to how to attack it, Paris said.

"In this case, I don't think I have ever seen this little amount of snow stick so quickly after temperatures being in the 50s during the day and ultimately dropping to 13 degrees over night," Paris said. "Also aiding us was that the snow was dry because of the extreme cold, so it was not as slick as a normal snowfall in the mountains. We were fairly certain based on weather reports, that the sun would shine all day on Friday and help melt most of the snow and that was the case.'

Paris and the Road Department braced for another Weather Event.

"Batten down the hatches as it will be extremely cold and windy and by the time you receive this paper," Paris said. "You should already be tired of cold weather as winter is starting off with a bang."
