It took a while, but the site was finally designed to satisfy Chick-fil-A.

Smith and Brent Cook with GDOT and they were able to understand what was going on," Griggs said. "They were able to pull everything together and get everyone talking to each other at the same time." Chick-fil-A site plans

filed with Union County Building and Development Department illustrate a 4,528square-foot building, with seating for 96 patrons within the restaurant, and outdoor seating to accommodate 15. The site proposes 49 regular parking spaces and three handicap parking spaces, totaling 52 parking spots.

Chick-fil-A bought the 1.02-acre lot from W. C. Nelson of Nelson Tractor Company, who also owns the piece of land between the proposed site of Chick-fil-A and Plott Street.

On the site plan, the lot is currently divided into two kinds of area: impervious and

pervious.

Impervious means the ground is covered in pavement, concrete or some other artificial material that goes into making building pads and parking lots, meaning that area would be impenetrable by water.

Existing acreage of impervious area sits right around .29 acres.

Once the restaurant is built, the site plan proposes the impervious area will increase to .84 acres out of 1.02 acres, with the rest of the lot going toward landscaping.

mitment is to providing the finest in healthcare services to our community," Efird said. "Union General Hospital has engaged an outside, independent organization to provide an objective review of our policies and procedures to seek areas for improvement in response to this incident."

Meanwhile, Union County Sheriff Mack Mason confirmed that his department has an active investigation regarding the case involving Dr. Gowder.

'Yes, we do have an on going investigation regarding this matter," Sheriff Mason

Dr. Gowder is free on bail from the Fannin County Detention Center, Commander Owens said.

Dr. Gowder was taken to the Fannin County Detention Center facing two charges, first-degree forgery, and obtaining dangerous drugs by fraud, Commander Owens said.

"He had written prescriptions for Oxycodone 15 mg, and what we're alleging is that he had forged doctors

signatures on those prescriptions," Owens said. "We're still looking into this and if there are other prescriptions out there, there will be more charges presented to the District Attorney's Office."

The investigation is on going in multiple judicial circuits, authorities say.

No further details were available at press time.
