incentive for counties to get storm debris removed sooner

Debris removal completed zero to 30 days from the start of the incident period, which would be Dec. 22, will receive a federal reimbursement

of 85 percent. Coupled with the 10 percent from the state, this leaves the local share for debris removal at 5 percent for debris cleaned up within 30 days from the very first day of storms.

For debris documented as having been removed between

31 and 90 days from the start of the storms, the federal cost share drops to 80 percent, and for debris removed 91 to 180 days, the federal share goes to 75 percent.

And according to a pilot program fact sheet made available in the April 6 meeting, "federal dollars will not be provided for debris removal after 180 days, unless an extension is granted by FEMA."

It is important to note that the federal disaster aid works as a reimbursement of costs, and not as a means of directly funding repairs, so all work completed must be well documented in order to receive the reimbursement, including invoices if work has been completed by the end of the 60 days, and estimates and quotes if the work has not yet been completed by the end of

the 60-day kickoff period.

were damaged, though without the need to replace culverts: Plott Town Road, Poplar Cove, Ridge Crest and Tate Road. We also had damage on

Butternut Creek Golf Course from Butternut Creek getting out of the banks in particular areas of the golf course, and that damage to the creek banks and golf course will have to be

repaired," said Hawkins. "We also had damage to the river banks of the Nottely River through Meeks Park in the Meeks Part II area near the bridge on Blue Ridge Highway and the new canoe launch. We also had damage in other areas of Meeks Park from the Butternut Creek.

Furthermore, the Union County Fire Department conducted two boat rescues during one of the flooding incidents, which will also be eligible for reimbursement up to 85 percent from federal and state sources. Leading the meeting

were Tara Teuta, a grant specialist with GEMA-HS, and Chris Nelson, the FEMA public assistance crew leader for Union County.

F E M AOther representatives made the meeting, including Rosalyn Cole, the federal coordinating officer appointed by President Obama to lead this particular disaster relief effort in Georgia.

"FEMA's mission is to support our citizens and first responders to ensure that, as a nation, we work together to build, sustain and improve our capability to prepare for, protect against, respond to, recover from and mitigate all hazards," said Cole, who urged everyone to download the FEMA app to their phones to get the latest on disasters and disaster preparedness.

Also in the meeting were: Union County Manager Larry Garrett, Fire Chief David Dyer, EMA/911 Director Charles Worden, Road Superintendent Tommy Tanner, C.J. Worden with GEMA-HS Field Operations and Richard Jones with Union County EMA.
