talk to staff or me. If you want to speak to me personally, the best way is to call my assistant at the above number and set up an appointment, because I am often out of the office and in the county checking on projects or at meetings. Fourth is through Facebook. I have a personal Facebook page that you can friend me on, however, I am very careful of who I friend so as to minimize hacking. Fifth is the newspaper. I furnish a Question and Answer column each week in the North Georgia News, the Legal Organ of the county. I have been submitting these Q & A for 15 years and as far as I know have never missed a week and have answered thousands of questions over the years to help keep you informed of what is going on in our county government, whether you are a native, newcomer, or somewhere in between. Then there is texting and fb messaging. It is often hard to keep up with all of these, but if someone says they cannot get in touch with me for a long time, it is usually not accurate.

Q. With all of these ways to contact you or the county does anyone ever fall through the cracks?

A. Yes and if you do, please contact us again. I was gone several days at the annual Commissioner Conference and immediately upon returning, I

was out of town an additional three days. That makes it very easy to get behind and sometimes simply forget. I also hand off issues to other departments and staff. But for the most part, you can get hold of our government relatively easy.

Q. Is one way better than another to get in touch with the county or you?

A. Usually, phone and email messages are the slowest, only because they are the easiest to send and there are so many to respond to. I currently have about 50 telephone calls to return and hundreds of e-mails. Now I do not have to respond to all the e-mails, but I must take the time to go through each one and either delete, forward to others or respond. So try to be patient if you can

plant to get rid of the lichens will not solve your problem. Currently, there are no recommended treatments for lichens that are also safe to use on plants. Spraying a plant that is already stressed and in decline with a home remedy or unapproved chemical could injure it or make its condition even worse. Instead, manually remove any unwanted lichens by gently scraping them from the bark. If you have an extensive lichen problem, you should also examine your plant for signs of disease or an insect infestation. A soil test is also recommended because most of the time, plant stress comes from a source under the surface that we can't see. The soil test

will show what nutrients are deficient in the soil and it will tell you what to add in order to improve it.

Though lichens can be an unsightly pest on our plants, they are actually a warning sign that there may be something wrong with your soil or the plant itself. It's important to scout your plants throughout the growing season, even your ornamentals, to make sure that there are no diseases or insects stressing them and ruining all your hard work!
