TSPLOST collected here. The State Economist forecasts Union County TSPLOST revenue collected over 10 years at \$45 million and we get our restricted projects at a cost of \$26 million plus local projects of \$18-20 million. \$44-46 million is way above the 60-65 percent predicted by those much less qualified than the State Economist.

Myth No. 3: The evil Transit Governance Study Commission is part of the ineptness.

Not exactly sure why transit is even mentioned in the Georgia Mountain Region since the only transit project on our region's restricted list is a few Express buses in south Forsyth County. Perhaps it's because transit is synonymous with MARTA and that generally scares

folks into a "no" vote. Myth No. 4: GDOT is incapable of managing their affairs.

Every good myth has a speck of truth and its true GDOT has suffered some mismanagement in the past few years. However the recent addition of Todd Long to GDOT's Executive Leadership team is a sure sign the department is returning to the professionalism of the past.

Myth No. 5: TSPLOST has an unfair impact on the poor, low income and citizens. fixed income There is no TSPLOST on rent or mortgage payments and motor fuel is exempt from the tax. So the basics of shelter and transportation are not impacted at all. Food is subject to the tax but not for those who are on food stamps assistance. So the impact on the poor is actually less than the impact on the middle class.

Finally near the end of the fable some truth does emerge - government is too big, has too many programs, taxes too much and interferes too much in our lives. Amen and let's do something about that. Unfortunately transportation infrastructure is one of the core responsibilities of government along with national defense, public works and public safety and is not the place to start. There is enough waste in non-essential services to reduce government significantly. So let's start there. So in the end YOU will decide how to vote on the TSPLOST Referendum on July 31.
