The school system's substitute teaching budget was slashed in half.

Approximately 90 percent of the school system's budget is attributed to salaries and benefits.

In Woody Gap, the salaries amount to more than \$1 million. There, the school board eliminated two teaching positions, cut four certified positions, won't replace

the school's counselor and will reorganize the school's cafeteria to cut costs.

As for the personnel cuts, Superintendent Steppe said the cuts were not personnel, just business.

"Trust me, I don't enjoy cutting teaching positions or staff positions," he said. "It was one of the many measures we're having to take to balance the budget.

Superintendent Steppe said that the systemwide personnel cuts are final, but that he's not expecting anymore to happen. He's going to recommend that the school system's use of furloughs be reduced below the eight days teachers have faced in the last couple of years.
