The KKK's modus operandi is to stay low key. That hasn't been the case with a recent string of stories posted from coast to coast.

All this to say, when I heard that the International Keystone Knights of The Realm of The Ku Klux Klan were anxious to adopt a portion of Highway 515 in Union County to keep it clean and free of debris, well, I was taken aback.

It came as a surprise that there was an organized KKK group here in Union County.

So, I did a little digging. I went to City Hall, where much to my surprise, I found an approved application for a fund-raiser on Sept. 8 around the city. I also found an approved application for a rally on Oct. 6, this time in front of the Union County Courthouse.

Times are hard and the city can't afford to be sued for not approving those applications, if you can ever afford to be sued for anything.

I secured copies of the applications. I did a little research in neighboring counties, including Union and low and behold, it turns out the members of the International Keystone Knights of The Realm of The Ku Klux Klan don't live in Blairsville or Union County at all.

The cold hard truth is, Fannin County, home of the Rebels, is the home of the exalted cyclops and his wife. Although, she doesn't sign her name to important documents with her married name.

Come to find out they live in Fannin County, an investigation by the North Georgia News has revealed.

In an interview with the North Georgia News, Chambers said that "Chambers or Hanson" might not be here real name at all. She also said the fundraiser/recruitment event in September might not happen. The same holds true for the Oct. 6 KKK Rally on the County Courthouse steps.

Meanwhile, back to the Adopt-A-Highway permit, I wondered why all the rush to pick up trash in Union County, especially if they live in Fannin County.

Blairsville Police Chief Johnny Carroll shed some light on that. He said that the

## Adopt a Mile

**Q. Why has there been such a state and national interest in the KKK applying for an application to pick up litter (Adopt a Mile) on Hwy 515 in Union County?**

A. I figure that it must have really been a slow news week and maybe everyone was ready to talk about something besides politics.

**Q. Were you contacted by the news media about the Adopt a Mile program on Hwy 515 related to the KKK?**

A. We have had several folks contacting us from the news media including Channel 2, PBS and FOX out of New York, along with local media.

**Q. Do you agree with the recent decision by the Georgia Department of Transportation to deny the application of the KKK?**

A. I sure do. My understanding was that GDOT had two choices. Either stop the Adopt a Mile program state wide, or deny the application to the KKK. It is doubtful that there were really any sincere folks from out of town actually wanting to come to Union County and pick up our trash. It appears their main purpose was to gain publicity and they certainly succeeded in that.

**Q. Why was Union County chosen by the KKK to Adopt a Mile for litter pickup?**

A. We are not totally sure, but Union County has a very active anti-litter program through North Georgia Resource Management Authority (NGRMA - Keep Our Mountains Beautiful) program. We have worked very closely with GDOT to keep our section of Hwy. 515 in Union County free of most litter. We have encouraged people to adopt a mile, not only on the county road system (called Adopt a Road) but on Hwy 515. We do not control the program on Hwy 515, but since it is a state highway, if we are contacted directly, we simply pass the Adopt a Mile applications along to GDOT. This particular section of highway was one that had not been adopted. This was apparently due to the speed limit limitation for Adopt a Mile being 55 mph. Since those applying for the permit actually live in Fannin County, it is even more amazing that they chose the first mile within Union County to apply for instead of the last mile in Fannin County.

**Q. The address of the couple involved was listed as a P.O. Box in Union County. Where do they live?**

A. That is the sad part about Union County getting caught up in this bad publicity. The couple actually lives in Fannin County. I have no idea why they have a P.O. Box here in Blairsville.

**Q. Are you aware of there being any KKK members in Union County?**

A. I have not heard of any and certainly hope that we do not have, but I have no way of knowing for sure. If we do, they certainly have been quiet and have not caused any problems in the past. This is not a group that is representative



## Making Music

When we think of the great institutions of music education in this country, Julliard, the Peabody Institute and the Boston Conservatory, all northeastern academies, come to mind. But Georgia Tech? Sure, they have a great band at half time shows, but innovators in music? In fact, the Georgia Tech Center for Music Technology is the breeding ground for the development of new musical instruments. Every year they host an International Competitor in musical instrument design. This year's winning creation was an armband that transmits vibrations from your muscles into sound, and one's arm movements become compositions.

In 1851, ten years prior to the Civil War, another great instrument was invented and first manufactured in Georgia. An African American from Macon, GA designed a tube with a piece of material that vibrated with the players hum. He took his idea to a German immigrant clock maker in town who manufactured a mirliton, or as we know it, a Kazoo.

The Kazoo was introduced in 1852 at the Georgia State Fair. And the Union County Farmers Market is celebrating this accomplishment 160 years later at our 3rd Annual Green Bean Festival, with the formation of the Market's "Green Bean Kazoo Band".

This year's Green Bean Festival is being relocated from Downtown Blairsville to the Farmers Market location where it can spread its wings. A committee of volunteers has been hard at work for months to assure that Saturday, July 28th, holds the key to the best food, fun and family entertainment of the summer.

Part of the plans for the merriment include bringing together young and old alike in a community band with an instrument any one can play proficiently. If you can hum you can play a kazoo! Interested in joining the band? Visit www.GreenBeanFestival.com for details.

That brings me to another musical opportunity for local musicians. This year we have taken the booth in the center of the Market and dubbed it "Blackberry Jam Sessions", where educational sessions will be held on Tuesday afternoon markets and on Saturday, the booth will be swinging with live music. ## HRWC Needs Your Help

**Dear Editor,**  
As a member of the Hiwassee River Watershed Coalition (HRWC), I want to ask as many of the residents of Towns and Union Counties in Ga and Clay and Cherokee in NC as possible that you consider helping keep the water(s) of the Hiwassee Watershed clean.

HRWC is a 16-year-old, local, non-profit organization dedicated to sustaining good water quality in streams, lakes and rivers that flow into the Hiwassee River. This includes almost all of Cherokee and Clay counties in North Carolina and Towns and Union counties in north Georgia. Lake Chatuge, Lake Nottely and Hiwassee Lake are all part of the Hiwassee River watershed.

The coalition works with local landowners, governments, schools and businesses to recognize and address threats to our water resources. The coalition has a staff of knowledgeable professionals who plan and implement volunteer-powered projects to solve problems before water quality is beyond reasonable recovery.

They also conduct education programs for all ages about water quality concerns and what individuals can do to help.

Due to many factors, first of which is the current economy, many of the coalition funds have been reduced or become unavailable. Lately there have been many public service ads on TV, and pop-up ads on the web, showing the concern for water quality and availability. There have been numerous books written over the past few years (most recently a well researched book titled The Ripple Effect, by Alex Prod'homme which I think EVERYONE should read) explaining the crises that exists not only locally but throughout the world.

For humans there are no needs as important as water. Most people use much more water than they think about. All beverages contain water whether they are water, sodas, alcohol, or pure fruit or vegetable drinks. We use water to bath, water our lawns and gardens. We use water to cool our vehicles, etc., etc., etc.. Agriculture is the largest user of water not only due to crop irrigation but even to produce a pound of beef studies show 2500 gallons of water are needed.

I've asked many people in the area if they
