Mr. Hobert Lunsford was working in Detroit, MI when on December 6, 1950 he received orders to report to Fort Jackson for basic training. He remained at Fort Jackson until September 1951. In September he received orders for Korea. In Korea Mr. Lunsford served on the front lines with a combat infantry division defending Hill 355. In April 1952, he was assigned to the 558 MP Company as a security guard for Generals Ridgway and VanFleet and later as a security guard at the Panmunjom Peace Conference. Mr. Lunsford returned to the
