A \$30,000 opinion

However, for the report prepared by Steven Minor for BRMEMC to indicate that former and now deceased BRMEMC Board Member Jack Lance Sr. knew about the debt as early as 2009, well, where did you get that information? Possibly from a current and sitting board member?


Unless Minor has a Quija Board, that's the only place Minor could have gathered the information.

Do you like the sound of your voice? The first time I heard a recording of my voice I was embarrassed. Our voices sound peculiar to us. Are any of you old enough to remember the TV show "This Is Your Life"? A guest would be chosen to appear on the show and various persons from

A ventriloquist throws his voice; a comedian changes his voice to sound like a variety of personalities. There is the voice of rejoicing and the voice of weeping. Cain killed his brother Abel and buried him, but his voice cried out from the earth (Gen. 4:10). You remember Rebecca connived with Jacob to deceive Isaac into giving Jacob the blessing instead of Esau. Rebecca placed goat's hair on Jacob's hands and smooth of his neck. When he approached Isaac, his father, Isaac felt his hands and neck and said, "The voice is Jacob's but the hands are the hands of Esau" (Gen. 27:22). Isaac was deceived because he went on feeling and failed to listen to the voice. When John the Baptist came preaching he was asked who he was, one of the prophets or the Messiah. John identified himself by saying, "I am the voice."

The sound of some voices are special: your spouse, your children, mom and dad, your siblings and friends. Being a preacher I listen to the sound and tone of speakers and preachers. Who of us would fail to recognize Billy Graham's voice? Dr. R. G. Lee had a unique voice. In his sermon Payday Someday he changed his voice to imitate the characters of Ahab, Jezebel, Eli-

A. Several people have asked me about this lately and a lot of information has been batted around. So out of concern and to try to get some accurate information I recently set up a meeting with several of the parties involved.

Q. Who attended your meeting to discuss the new Murphy Casino? A. Myself, Mitch Griggs, Director of our Economic Development office, Mayor Jim Conley,

Georgia Department of Transportation representative, Brent Cook, and then two members representing the new Harrah's Casino.

Q. What will be the name of the new casino?

A. It will be called the Harrah's Cherokee Valley River Casino in Murphy, NC. Q. How many guest rooms will be available at the new

A. There will be constructed on site a 300-room hotel. Q. What is the construction budget of the entire project? A.The budget is for \$110 million. That will consist of a

108,000 square foot casino with 50 to 75 gaming tables and 1,100 to 1,200 slot machines all sitting on 35 acres. Q. How many jobs will be available at the casino? A. The estimated number of jobs will be between 800 and

900 with an annual payroll of between \$32 million and \$39 mil-

lion. Executive level positions will be hired in the third quarter of this year and manager level hirings will begin by the fourth quarter

Q. When will the Murphy Casino open? A. They estimate that the casino and hotel will open in June/

Q. Who did your group meet with from the new Casino? A. We met with two gentlemen. Lumpy Lambert is the Assistant General Manager of the current Cherokee, NC Casino and will become the General Manager of the new Murphy Casino. He

was accompanied by Ryan Downs, the project engineering manager. Both gentlemen were very nice and answered all questions See **Paris**, page 5A


