years, we rely on experts in the field to make those estimates.

The current SPLOST began in April 2009, but planning of projects and estimates were made back in 2007 and 2008. That was before the fi-

nancial collapse and economic downturn.

The SPLOST law is designed to take these factors into account.

It is obvious that estimates of revenue can vary and the cost of individual projects can vary widely.

We can make educated estimates on all of it, but who could have guessed the severity of the fall of the economy back in late 2008 and the severe financial impact it would have on the entire world, much less Union County.
