have 2 utility all terrain vehicles to assist with off-road and trail rescues, the proper equipment to hoist a patient out of the woods via a helicopter, a mobile command center to accommodate the management of major incidents, 4 thermal imaging cameras that see through smoke and help with night searches, and much more. They are prepared to help Union County citizens with any situation that arises. Much of this special equipment has been obtained with grants. Thankfully, our Fire Department is very proactive in going after grants. We also appreciate very much the donations made by residences (full and part time) of the county to each volunteer fire station, helping them keep their personal equipment upgraded and safe.

Q. How many structure fires and other calls does the Fire Department typically respond to in a year? A. The Fire Department

responded to 1,914 calls last year. Out of the 1,914 calls, the firefighters responded to 45 structure fires, 16 vehicle fires, 48 brush or grass fires, and 9 other miscellaneous fire calls. They responded to 1,148 medical calls to assist the ambulance. 151 responses were to motor vehicle accidents. Search and/or Rescue calls accounted for 54 of the calls. There were 241 calls the firefighters responded to which includes calls such as ani-

mal rescue, smoke complaints, traffic control, public education, and assisting other agencies. 147 calls were cancelled before firefighters arrived on scene. There were 32 fire alarm calls. There were 19 hazardous condition calls such as fuel leaks and carbon monoxide incidents.

Q. What do the firefighters do when they are not responding to fires?

A. This may come as a surprise, but firefighting is only a small part of their job. As reported in the previous question they respond to many other situations other than structure fires. They are required to have 120+ hours fire training and 36+ hours of medical training per year. Some of their other responsibilities are pre-fire plans, which have to be updated twice a year; public safety and fire education with schools (including visits with Sparky recently seen at the Sorghum Festival Parade), nursing homes, and other businesses in the community; all yearly hose testing on each vehicle; daily equipment and vehicle inspections for readiness; breathing apparatus to assure functioning properly; smoke alarm installations, traffic control/parking at most county/city events, parades and much more. We truly appreciate all our emergency services personnel do for the citizens of Union County.
