
The Birth That **Brought Him**





the civil war. None of them were slave owners. Is this a good thing or a bad thing? They fought to defend their farms, families, black smith shops, and wagon manufacturing. One of them stayed in Atlanta to hold the invading army back so the whites, blacks, sick and wounded could get out before their homes were burnt to the ground. This caused him to be captured and shipped off to a POW camp in Indiana which some people in Nebraska say was worse than Andersonville.

After the war was over, he walked back to Hall county and got on about his business.

Years later, his son hid a young black girl with his family for two or three weeks. She had run to his house when the whites started rioting in Gainesville. She wasn't his slave, she
