a better time.

"The Union County Senior Center is an amazing program," Paris said. "And it is truly amazing what's done by Kathy Hill, her staff, and the volunteers whose hard work and dedication keep the Senior Center going."

Funding for the expansion came via a highly competitive Community Development Block Grant from the state Department of Community Affairs of almost \$300K. The grant is the culmination of many concerted efforts by various supporters of the Senior Center.

Paris said that a major reason that this money was granted for the Senior Centers expansion project, "is due to Kathy Hill's hard work, determination, and enthusiasm," that she has for the Senior Center and who it represents.

Bill Lassard, one of the center's appreciative patrons, summed up this same senti-

Lassard wanted to express his depth of gratitude to Hill. He expressed to all those present that "everything Kathy has done here at the Center is above and beyond, and whatever salary she is making, is not nearly enough."

The grant from DCA through their CDBG program is open to all Georgia counties; the purpose is to "enhance the quality of life," and for this project, according to Patrick Larson, a representative of the Economic Development staff of the Georgia Mountain Regional Commission.

"This CDBG was awarded to the Senior Center to help the community to better serve Seniors in Union County," Larson said. "So congratulations are in order to the Seniors, the Center, and the entire community for all of the hard work that has been done on this people project.

Without the community coming together, as you have done here in Union County for the sole benefit of the Senior Center, this project would have

never come together," Larson said. "These grants are getting more and more difficult, and more and more competitive, so the fact that Union County was awarded this project expansion grant is impressive.

Furthering this remarkable achievement was Lamar Gailey, the Community Program director for Legacy Links. Legacy Links is the Area Agency on Aging (AAA) for 13 North Georgia counties, and the agency is responsible for advocacy for seniors, planning, and administration of programs, coordination and the monitoring of services in

Gailey, who travels throughout North Georgia, extended appreciation for the strength of the community in Union County. He congratulated the county on the "beautiful and new improvements" made to the facility dedicated to the advocacy and outreach for the Senior Citizens of Union

County.

"This project was a priority project due to the crowded conditions and lack of floor space for the activities, which hinders the provision of services, for a growing number

of clientele," Paris said.
"The Senior Center is growing, and the lack of space made it tough, we had only one activities room which served

as the workspace for most of the programs administered by the center; workspace that was "cramped and crowded," Hill said.

Paris said that the entirety of the funds went towards the renovation and expansion of the Senior Center," and as Hill proudly showed, this grant money funded the new activities room, a meeting/functions

"There was enough money left over to expand the kitchen area, which is the heart of the county's Meals-On-Wheels program," Hill said.

Meals-On-Wheels is projected to serve 24,000 meals during 2013.

In recognition of the new activities room, Hill, dedicated on behalf of the Mountain Line Dancers, the original activities room to Jeannette Hudack, "our inaugural line dancing teacher who brought entertainment and smiles to all she met."

After the ribbon was officially cut, the assemblage was treated to refreshments, entertainment by the Mountain Line Dancers and by the dulcimer players, Mountain Sounds, and invited to tour the newly expanded Union County Senior Center.
