

Tails never fails: Panthers win tie-breaking coin toss for No. 1 seed

UCHS to host boys' Region 8-AA basketball tournament starting Wednesday

The Union County Panthers will host this week's Region 8-AA boys tournament as the No. 1 seed courtesy of last week's blowout win over Fellowship Christian and two lucky bounces at Banks County.

Three different outcomes all needed to break in Union's favor to leapfrog first-place Providence Christian (21-4, 8-2) for the top spot and home court advantage in the Region 8-AA tournament. First, the Panthers defended their home court in the regular-season finale, dominating Fellowship Christian 72-45 on Tuesday, Feb. 7.

After the win, Union County players, coaches and fans were glued to their phones, awaiting the outcome of 10thranked Providence at Banks County. With Panther Nation cheering the Leopards on from 65 miles away, Banks County (17-8, 7-3) held off a late rally when the Storm's game-tying 3-pointer bounced off the iron as time expired.

Twelve hours later, Union County head coach Corey Garrett attended the Region 8-AA meeting in Homer, where the tie-breaking coin toss took place between the Panthers and Storm

And for the second straight day, fate was on Union's side in Banks County.

"On the way down [to Banks County for the coin toss], I had a lot of time to think about what I was going to call and whether or not I was going to call it or let Providence call it," Union County head coach Corey Garrett said. "I decided that I was going to go in there and call tails and that's pretty much what I did. So I go in and they said, 'we've got to do the coin toss, how do you want to do it?' I said, 'grab a coin and toss it, but I call tails.

"Then they went back and forth about [designating] one team heads and one team

"I think we're ready," Garrett said on Monday morning. "The guys are definitely excited, we just need to put the finishing touches on a few things these next two days. We didn't know who we would play until Saturday but we had an idea. This week, we're going to dive in pretty deep putting together a gameplan [for Athens Academy] and just get to work."

The Panthers-Spartans contest will follow the 6 p.m. matchup between second-seeded Providence and third-seeded Banks County.

The Region 8-AA Championship and the third-place game will be Friday, Feb. 17, at Union County High School.

'Cade came in [when Henry went out] and did a good job," Garrett said. "It wasn't our cleanest game offensively, but we were effective enough to get the win."

Trailing 4-2 early, Union County seized the lead for good with a 7-0 run en route to an 18-12 advantage after one. After an Ellis trey to begin the second, Young scored five straight to build a 26-15 advantage.

Hughes closed the half with two 3s in the final minute to turn an 11-point lead into a 38-21 blowout.

Dockrey, Underwood and Ellis accounted for six straight to start the third, capping a 12-0 stretch with a 44-21 lead. Dockrey, Underwood and Young extended the margin to 53-27 before Fellowship briefly moved within 20 at 53-34 with 24 seconds left. But Dockrey quickly nudged the Panthers back up 55-34 at the quarter's end with a tip-in at the buzzer.

Underwood, Young and Hughes kept Union County on top 61-40 near the 5-minute mark, then triples from Young

to 67-45 with 2:58 remaining. Ellis finished with 7 points and five rebounds. Sophomore Braden Plott scored 2 points; junior Anderson Cruise added a rebound and a steal. Union County ended with a seasonhigh 20 made free throws, one game removed from making a season-best 86% from the line at East Jackson. Sophomore Kaden Combs pulled down two boards, and sophomore Brayden Hogsed grabbed one rebound.

Bowen Hudson led Fellowship with 15 points.

7:30 p.m. The Spartans clinched a spot in the semifinals with a 79-74 win over East Jackson in Saturday's play-in game. Later that day, Banks County earned a semifinal date with Providence via a 63-40 victory over Fellowship

With a Union win vs. Athens Academy, the Panthers would reach consecutive region title games for the first time since 2000 and 2001. Union County would also host the first round of state with a victory on Wednesday.

The Panthers are looking for their third win over Athens Academy after defeating the Spartans 68-50 in Athens on Jan. 6 and 78-63 in Blairsville on Jan. 27. Wednesday's clash also marks the sixth meeting in 13 months between Garrett and coach Don Hurlburt, who previously coached at Elbert County before taking over the Spartans.

The winner will face the Banks County-Providence winner on Friday at 7:30. The two losers will meet at 6 p.m. in the consolation game.

Region 8-AA is paired with Region 7-AA in the first round of next week's state tournament. Model (18-4, 10-2) and North Murray (21-2, 10-2) finished tied atop the region standings, with Murray County (10-12, 8-4) and Rockmart (14-12, 7-5) in third and fourth, respectively. Haralson County (12-13, 4-8), Gordon Central (10-13, 3-9) and Fannin County (2-22, 0-12) round out the bottom of the region.

Eatonton - Union County qualified six individuals for this weekend's Class AA State Championships in Macon, headlined by Junior David Heredia and sophomore Payton Legatt's first-place finishes during last Saturday's State sectionals tournament at Putnam County High School.

Union County senior Huck Whisenhunt, juniors Anderson Clouse and Zander Rotko, and sophomore Asa Smith-Foot also advanced to Macon with top-six sectional performances.

Legatt came in first at 157 lbs courtesy of a first-round pin over Westside-Augusta's Jeanarion Kamga in the tournament finals.

Following a bye in the opening match, Legatt notched a pair of second-round pinfalls over Toombs County's Michale Jones and Putnam County's Mark Winslette to secure a spot in the finals.

At 165 lbs, Heredia opened with a forfeit victory, then pinned Brantley County's Harlan Pruitt during the second round in match two. Heredia needed only 49 seconds to se-

decision during the semis, but Smith-Foot bounced back with a second-round pin over Mt. Paran's Ryder Schaltenbrand.

Smith-Foot dropped a 15-9 decision to Fannin County's Drake Cantrell in the consolation finals to finish fourth.

Rotko placed fifth at 138 lbs, securing a 9-5 opening bout victory over Pierce County's Zach Davis. After falling by pinfall to Putnam's Armon Webster in his second match, Rotko pinned East Jackson's Evan Reed and Mt. Paran's Wheeler Green.

Rotko suffered a loss in the consolation semifinals but rebounded in his rematch vs. Webster, earning a 12-2 major decision to take home fifth place.

Other Union County wrestlers were Riley Morttenson at 113, Thomas Gary at 120, Colson Lotts at 144 and Jackson Arthur in the 285-lb division.

On Friday night, Union senior Shelby Agacinski placed eighth at the girls' sectionals tournament in Toccoa.

The Class AA State Championships open Friday morning at the Macon Centreplex. The event wraps up on Saturday.

Lady Panthers sink Fellowship, enter Region tournament as No. 3 seed

The Lady Panthers (14-11, 4-4) enter this week's Region 8-AA tournament as the No. 3 seed and will face second-seeded Athens Academy on Tuesday, Feb. 14 at Banks County.

By locking down a topthree seed, Union County secured its fourth consecutive State playoff berth and needs a win over Athens Academy to play in the region title game for the second time since 2020.

The Lady Panthers enter the postseason in third place via last week's 56-36 win over Fellowship Christian and Athens Academy's victory at East Jackson (11-15, 3-5). Union County went into the Feb.7 meeting with Fellowship still in the hunt for the No. 2 seed but needed a win over the Paladins plus an East Jackson victory against Athens Academy to force a three-way tie for second. The Lady Panthers handled their business vs. Fellowship, but Athens Academy (17-5, 5-3)clinched the No. 2 seed with a 45-33 win over the Eagles

Union County and Athens Academy will meet at 6 p.m. Tuesday at Class AA's third-ranked Banks County. Union County dropped its first three games of 2023, suffering two losses to White County and one to Fannin County last week.

On Wednesday, Feb. 8, the Panthers allowed seven first-inning runs and three more in the second during a 10-1 home loss to White County. Union County fell 3-0 at Fannin County on Friday, Feb. 10, then dropped an 8-4 contest at White County the following day.

Panthers 1, White County 10 - Eli Sosensky's two-out RBI single in the fifth accounted for Union's only run of the day, driving home Maddox Patton, who reached via a one-out single -- his team's first hit of the game.

Patton's day ended 1 for 2 with a walk and a stolen base. Sosensky went 1 for 3 with two steals; Will Duncan walked twice and swiped a bag. Jordan Gilliam collected two bases on balls, a hit-by-pitch and a stolen base. Moses Stephens and Connor Swanson added one walk apiece. Brayden Sweat was hit by a pitch.

Duncan got the start on the mound and lasted one inning, giving up four hits, three walks and six earned runs. Lane Haney allowed four hits and three earned runs over two innings, surrendering three walks and a homer.
